## **SCOPE of SERVICE**

The Office of Utilities Regulation (OUR), the telecommunications regulator, invites applications for a Telecommunications Licence in the following category: Service Provider Licence - to operate a Number Portability Central Reference Database and associated Automated Order Handling Process.

This licence will grant to the successful applicant the required permission, as the Number Portability Administrator, to manage and coordinate activities related to number portability in accordance with the published industry code of practice and operational guidelines for the number portability process, to facilitate the provision of number portability service by public telecommunications carriers in Jamaica.

### **ELIGIBILITY**

For the purpose of the application for the licence it should be noted that:

- One (1) licence will be granted.
- A non-refundable application fee of US\$2,000 must accompany each licence application.
- Completed application forms along with the required supporting documents will form the basis for evaluating the applications and recommending the grant of the licence.
- There is no limit on the percentage of foreign ownership of the equity of any applicant.
- The successful applicant will be required to be a corporate entity registered under the laws of Jamaica.
