## Section 1. Letter of Invitation



Dear Sir/Madam:

1. The Office of Utilities Regulation ("OUR") has committed funds to undertake a comprehensive assessment of competition in the supply of fixed and mobile telephony and data services in Jamaica.
2. The OUR now invites proposals to provide the following consulting services: Consultancy for the Conduct of an Assessment of Competition in the Supply of Electronic Communication Services. More details on the services are provided in Section 5: Terms of Reference.
3. A firm will be selected under the Quality Cost-Based Selection method described in Volume 3 of the Government of Jamaica Handbook of Public Sector Procurement Procedures (Updated March, 2014) which can be found at the following website - [www.mof.gov.jm](http://www.mof.gov.jm) - as well as the procedures described in this RFP.

## Section 2. Instructions to Consultants

### Definitions

- a. "OUR or Procuring Entity" means the Office of Utilities Regulation.
- b. "Consultant" means any entity or person that may provide or provides the Services to the OUR under the Contract.
- c. "Contract" means the Contract signed by the Parties and all the attached documents as listed in its Clause 1, that is, the General Conditions (GC), the Special Conditions (SC), and the Appendices.
- d. "Data Sheet" means the part of the Instructions to Consultants used to reflect specific assignment conditions or amendments to these Instructions to Consultants.
- e. "Day" means calendar day.
- f. "Government" means the Government of Jamaica
- g. "Instructions to Consultants" means this document included as Section 2 of the RFP.
- h. "LOI" means the Letter of Invitation included in the RFP at Section 1.
- i. "Personnel" means such professionals and support staff provided by the Consultant or by any Sub-Consultant and assigned to perform the Services or any part thereof; "Foreign Personnel" means such professionals and support staff who at the time of being so provided had their domicile outside of Jamaica; "Local Personnel" means such professionals and support staff who at the time of being so provided had their domicile inside Jamaica.
- j. "Proposal" means the Technical Proposal and the Financial Proposal.
- k. "RFP" means this Request For Proposal.
- l. "Services" means the work to be performed by the Consultant pursuant to the Contract.
- m. "Sub-Consultant" means any person or entity to whom the Consultant subcontracts any part of the Services.
- n. "Terms of Reference" or "TOR" means the document included in the RFP at Section 5 which explains the objectives, scope of work, activities, tasks to be performed, respective responsibilities of the OUR and the Consultant, and expected results and deliverables of the assignment.

### 1. Introduction

- 1.1 The OUR will select a consulting firm/organization to provide the Services in accordance with the method of selection

specified in the Data Sheet.

- 1.2 Consultants are invited to submit a Technical Proposal and a Financial Proposal for consulting services required for the assignment named “**Consultancy for the Conduct of an Assessment of Competition in The Supply of Electronic Communication Services**”. The Proposal will be the basis for contract negotiations and ultimately for a signed Contract with the selected Consultant.
- 1.3 Consultants should familiarize themselves with local conditions and take them into account in preparing their Proposals. To obtain first-hand information on the assignment and local conditions, Consultants are encouraged to attend the pre-proposal conference if one is specified in the Data Sheet. Attending the pre-proposal conference is optional. Consultants should contact the Procuring Entity’s representative named in the Data Sheet to arrange for their visit or to obtain additional information on the pre-proposal conference. Consultants should ensure that these officials are advised of the visit in adequate time to allow them to make appropriate arrangements.
- 1.4 The OUR will timely provide, at no cost to the Consultants, the inputs and facilities specified in the Data Sheet, assist the firm in obtaining licences and permits needed to carry out the services, and make available relevant project data and reports.
- 1.5 Consultants shall bear all costs associated with the preparation and submission of their proposals and contract negotiation.

***N.B. The OUR is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultants. The OUR reserves the right not to award a contract to any party with whom we are currently in litigation or in the past engaged in litigation.***

**Conflict of Interest**

- 1.6 Consultants are required to provide professional, objective, and impartial advice and at all times hold the OUR’s interests

paramount, strictly avoid conflicts with other assignments or their own corporate interests and act without any consideration for future work.

1.6.1 Without limitation on the generality of the foregoing, Consultants, and any of their affiliates, shall be considered to have a conflict of interest and shall not be contracted, under any of the circumstances set forth below:

**Conflicting activities**

(i) A firm that has been engaged by the OUR to provide goods, works or services other than consulting services for a project, and any of its affiliates, shall be disqualified from providing consulting services related to those goods, works or services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, and any of its affiliates, shall be disqualified from subsequently providing goods or works or services other than consulting services resulting from or directly related to the firm's consulting services for such preparation or implementation. For the purpose of this paragraph, services other than consulting services are defined as those leading to a measurable physical output, for example surveys, exploratory drilling, aerial photography, and satellite imagery.

**Conflicting assignments**

(ii) A Consultant (including its Personnel and Sub-Consultants) or any of its affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant to be executed for the OUR or for another procuring entity. For example, a Consultant hired to prepare engineering design for an infrastructure project shall not be engaged to prepare an independent environmental assessment for the same project, and a Consultant assisting the OUR in the privatization

of public assets shall not purchase, nor advise the procuring entities of, such assets. Similarly, a Consultant hired to prepare Terms of Reference for an assignment should not be hired for the assignment in question.

**Conflicting relationships**

- (iii) A Consultant (including its Personnel and Sub-Consultants) that has a business or family relationship with a member of the OUR's staff who is directly or indirectly involved in any part of (i) the preparation of the Terms of Reference of the assignment, (ii) the selection process for such assignment, or (iii) supervision of the Contract, may not be awarded a Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the OUR throughout the selection process and the execution of the Contract.

1.6.2 Consultants have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of the OUR, or that may reasonably be perceived as having this effect. Failure to disclose said situations may lead to the disqualification of the Consultant or the termination of its Contract.

1.6.3 No agent or current employees of the OUR shall be permitted to work as Consultants in connection with the project to which this RFP relates. Recruiting former employees of the OUR to work on this project is acceptable provided no conflict of interest exists. If the Consultant nominates any Government employee as Personnel in its technical proposal, such Personnel must have written certification from the Government or their employer confirming that they are on leave without pay from their official position and allowed to work full-time outside of their previous official position. Such certification shall be provided to the OUR by the Consultant as part of its technical proposal.

**Unfair  
Advantage**

1.6.4 If a Consultant could derive a competitive advantage from having provided consulting services related to the assignment in question, the OUR shall make available to all other Consultants together with this RFP all information that would in that respect give such Consultant any competitive advantage over competing Consultants.

**Fraud and  
Corruption**

1.7 The OUR requires that Consultants, observe the highest standard of ethics during the procurement and execution of its contracts. In pursuit of this policy:

(a) the terms set forth below for the purposes of this provision, are defined as follows:

**“corrupt practice”** means the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the action of a public official in the procurement process or in contract execution;

**“fraudulent practice”** means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract, to the detriment of the OUR and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the OUR of the benefits of free and open competition;

**“collusive practice”** means a scheme or arrangement between two or more bidders, with or without the knowledge of the OUR, designed to establish bid prices at artificial non-competitive levels or to influence the action of any party in the procurement process or the execution of a contract; and

**“coercive practice”** means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of a contract;

(b) the OUR will reject a proposal for award if it determines

that the Consultant recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question;

- (c) the OUR will sanction a firm or individual, including declaring them ineligible, either indefinitely or for a stated period of time, to be awarded a contract with the OUR if it at any time determines that they have, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for, or in executing, a contract with the OUR; and
- (d) the OUR will have the right to require that a provision be included in the RFP and in its contracts, requiring Consultants to permit the OUR to inspect their accounts and records and other documents relating to the Bid submission and contract performance and to have them audited by auditors appointed by the OUR.

1.8 Consultants shall furnish information on commissions and gratuities, if any, paid or to be paid to agents relating to this proposal and during execution of the assignment if the Consultant is awarded the Contract, as requested in the Financial Proposal submission form (Section 4).

**Origin of Consulting Services**

- 1.9 Consulting Services provided under the Contract may originate from any country except where:
- the procurement is covered under a Free Trade Agreement
  - a multilateral funding agency policy which limits the origin.
  - the procurement is limited to local consultants.

**Only one Proposal**

1.10 Consultants may only submit one proposal. If a Consultant submits or participates in more than one proposal, such proposals shall be disqualified. However, this does not limit the participation of the same Sub-Consultant, including individual experts, to more than one Proposal.

- Proposal Validity**
- 1.11 The Data Sheet indicates how long Consultants' Proposals must remain valid after the submission date. During this period, Consultants shall maintain the availability of Professional staff nominated in the Proposal. The OUR will make its best effort to complete contract negotiations within this period. Should the need arise however, the OUR may request Consultants to extend the validity period of their Proposals. Consultants who agree to such extension shall confirm that they maintain the availability of the Professional staff nominated in the Proposal, or in their confirmation of extension of validity of the Proposal, Consultants could submit new staff in replacement, who would be considered in the final evaluation for contract award. Consultants who do not agree have the right to refuse to extend the validity of their Proposals.
- 2. Clarification and Amendment of RFP Documents/ Extension of Deadline for Submission of Proposals**
- 2.1 Consultants may request a clarification of any of the RFP documents up to the number of days indicated in the Data Sheet before the Proposal submission date. Any request for clarification must be sent in writing, or by standard electronic means to the OUR's address indicated in the Data Sheet. The OUR will respond in writing, or by standard electronic means and will send written copies of the response (including an explanation of the query but without identifying the source of inquiry) to all Consultants. Should the OUR deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure under paragraph 2.2 of these Instructions to Consultants.
- 2.2 At any time before the submission of Proposals, the OUR may amend the RFP by issuing an addendum in writing or by standard electronic means. The addendum shall be sent to all Consultants and will be binding on them. Consultants shall acknowledge receipt of all amendments. To give Consultants reasonable time in which to take an amendment into account in their Proposals the OUR may, if the amendment is substantial, extend the deadline for the submission of Proposals.
- 3. Preparation of Proposals**
- 3.1 The Proposal, as well as all supporting documentation and related correspondence exchanged by the Consultants and the OUR, shall be written in the English language.

3.2 In preparing their Proposal, Consultants are expected to examine in detail the documents comprising the RFP. Material deficiencies in providing the information requested may result in rejection of a Proposal.

3.3 While preparing the Technical Proposal, Consultants must give particular attention to the following:

(a) If a Consultant considers that it may enhance its expertise for the assignment by associating with other Consultants in a joint venture or sub-consultancy, it may do so. In case of a joint venture, all partners shall be jointly and severally liable and shall indicate in its Technical Proposal who will act as the leader of the joint venture.

(b) The estimated number of professional staff-months or the budget for executing the assignment shall be shown in the Data Sheet, but not both. However, the Proposal shall be based on the number of Professional staff-months or budget estimated by the Consultants.

**Language**

(c) Documents to be issued by the Consultants as part of this assignment must be in English. It is expected that the firm's Personnel be proficient in reading, writing, and speaking English.

**Technical  
Proposal Format  
and Content**

3.4 Consultants are required to submit a Full Technical Proposal (FTP). The Data Sheet indicates the format of the Technical Proposal to be submitted. Submission of the wrong type of Technical Proposal will result in the Proposal being deemed non-responsive. The Technical Proposal shall provide the information indicated in the following paragraphs from (a) to (g) using the attached Standard Forms (Section 3 of this RFP).

(a) A brief description of the Consultants' organization and an outline of recent experience of the Consultants and, in the case of joint venture, for each partner, on assignments of a similar nature is

required in Form TECH-2 of Section 3. For each assignment, the outline should indicate the names of Sub-Consultants/ Professional staff, duration of the assignment, contract amount, and Consultant's involvement. Information should be provided only for those assignments for which the Consultant was legally contracted by the OUR as a corporation or as one of the major firms within a joint venture. Assignments completed by individual Professional staff working privately or through other consulting firms cannot be claimed as the experience of the Consultant, or that of the Consultant's associates, but can be claimed by the Professional staff themselves in their CVs. Consultants should be prepared to substantiate the claimed experience if so requested by the OUR.

- (b) Comments and suggestions on the Terms of Reference including workable suggestions that could improve the quality/ effectiveness of the assignment; and on requirements for counterpart staff and facilities including: administrative support, office space, local transportation, equipment, data, etc. to be provided by the OUR (Form TECH-3 of Section 3 of the RFP).
- (c) A description of the approach, methodology and work plan for performing the assignment covering the following subjects: technical approach and methodology, work plan, and organization and staffing schedule. Guidance on the content of this section of the Technical Proposals is provided under Form TECH-4 of Section 3. The work plan should be consistent with the Work Schedule (Form TECH-8 of Section 3) which will show in the form of a bar chart the timing proposed for each activity.
- (d) The list of the proposed professional staff team by area of expertise, the position that would be assigned to each staff team member, and their tasks (Form TECH-5 of Section 3).

- 
- (e) Estimates of the staff input (staff-months of foreign and local professionals) needed to carry out the assignment (Form TECH-7 of Section 3). The staff-months input should be indicated separately for home office and field activities, and for foreign and local professional staff.
  - (f) CVs of the professional staff signed by the staff themselves or by the authorized representative of the professional staff (Form TECH-6 of Section 3).
  - (g) A detailed description of the proposed methodology and staffing for training.
- 3.5 The Technical Proposal shall not include any financial information. A Technical Proposal containing financial information may be declared non responsive.
- Financial Proposals**
- 3.6 The Financial Proposal shall be prepared using the attached Standard Form (Section 4). It shall list all costs associated with the assignment, including (a) remuneration for staff (foreign and local, in the field and at the Consultants' home office), and (b) reimbursable expenses indicated in the Data Sheet. If appropriate, these costs should be broken down by activity and, if appropriate, into foreign and local expenditures. All activities and items described in the Technical Proposal must be priced separately; activities and items described in the Technical Proposal but not priced, shall be assumed to be included in the prices of other activities or items.
- Taxes**
- 3.7 The Consultant may be subject to Jamaican taxes (such as: value added or sales tax, social charges or income taxes on non-resident foreign Personnel or resident Personnel, duties, fees, levies) on amounts payable by the OUR under the Contract. The OUR will state in the Data Sheet if the Consultant is subject to payment of any local taxes. Any such amounts shall not be included in the Financial Proposal as they will not be evaluated, but they will be discussed at contract negotiations, and applicable amounts will be included in the Contract.

- 3.8 Consultants may express the price of their services in a maximum of three freely convertible currencies, singly or in combination. The Procuring Entity may require Consultants to state the portion of their price representing local cost in the national currency if so indicated in the Data Sheet.
- 3.9 Commissions and gratuities, if any, paid or to be paid by Consultants and related to the assignment will be listed in the Financial Proposal Form FIN-1 of Section 4.
- 4. Submission, Receipt, and Opening of Proposals**
- 4.1 The original proposal (Technical Proposal and Financial Proposal) shall contain no interlineations or overwriting, except as necessary to correct errors made by the Consultants themselves. The person who signs the proposal must initial such corrections. Submission letters for both Technical and Financial Proposals should respectively be in the format of TECH-1 of Section 3, and FIN-1 of Section 4, respectively.
- 4.2 An authorized representative of the Consultants shall initial all pages of the original Technical and Financial Proposals. The authorization shall be in the form of a written power of attorney accompanying the Proposal or in any other form demonstrating that the representative has been duly authorized to sign. The signed Technical and Financial Proposals shall be marked "ORIGINAL".
- 4.3 The Technical Proposal shall be marked "**ORIGINAL**" or "**COPY**" as appropriate. The Technical Proposals shall be deposited in the Tender Box provided at the address referred to in paragraph 4.5 and in the number of copies indicated in the Data Sheet. All required copies of the Technical Proposal are to be made from the original. If there are discrepancies between the original and the copies of the Technical Proposal, the original shall govern.
- 4.4 The original and all copies of the Technical Proposal shall be placed in a sealed envelope clearly marked "**TECHNICAL PROPOSAL**". Similarly, the original Financial Proposal shall be placed in a sealed envelope clearly marked "**FINANCIAL PROPOSAL**" followed by the name of the assignment, and with a warning "**DO NOT OPEN WITH THE TECHNICAL PROPOSAL.**" The envelopes

containing the Technical and Financial Proposals shall be placed into an outer envelope and sealed. This outer envelope shall bear the submission address, reference number and title, and be clearly marked **“DO NOT OPEN, EXCEPT IN PRESENCE OF THE OFFICIAL APPOINTED, BEFORE 11:00 A.M. JAMAICA TIME ON JULY 13, 2015”**. The OUR shall not be responsible for misplacement, losing or premature opening if the outer envelope is not sealed and/or marked as stipulated. This circumstance may be cause for Proposal rejection. If the Financial Proposal is not submitted in a separate sealed envelope duly marked as indicated above, this will constitute grounds for declaring the Proposal non-responsive.

4.5 The Proposals must be sent to the address indicated in the Data Sheet and deposited in the TENDER BOX provided at that address for this purpose no later than the time and the date indicated in the Data Sheet, or any extension to this date in accordance with paragraph 2.3. Any proposal received by the OUR after the deadline for submission shall be returned unopened.

4.6 The OUR shall open the Technical Proposal immediately after the deadline for their submission. The envelopes with the Financial Proposal shall remain sealed and securely stored.

## **5. Proposal Evaluation**

5.1 From the time the Proposals are opened to the time the Contract is awarded, the Consultants should not contact the OUR on any matter related to its Technical and/or Financial Proposal. Any effort by Consultants to influence the OUR in the examination, evaluation, ranking of Proposals, and recommendation for award of Contract may result in the rejection of the Consultants' Proposal.

Evaluators of Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded.

### **Evaluation of Technical Proposals**

5.2 The evaluation committee established by the OUR (the “Evaluation Committee”) shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference, applying the evaluation criteria, subcriteria, and point system

specified in the Data Sheet. Each responsive Proposal will be given a technical score (St). A Proposal shall be rejected at this stage if it does not respond to important aspects of the RFP, and particularly the Terms of Reference, or if it fails to achieve the minimum technical score indicated in the Data Sheet.

**Public Opening  
and Evaluation  
of Financial  
Proposals**

- 5.3 After the technical evaluation is completed the OUR shall notify those Consultants whose Proposals did not meet the minimum qualifying mark or were considered non responsive to the RFP and TOR, that their Financial Proposals will be returned unopened after completing the selection process. Where possible the financial proposals should be opened publicly. In this case, the OUR shall simultaneously notify in writing Consultants that have secured the minimum qualifying mark, of the date, time and location for opening of their Financial Proposals. The opening date should allow Consultants sufficient time to make arrangements for attending the opening. Consultants' attendance at the opening of Financial Proposals is optional.
- 5.4 Financial Proposals shall be opened publicly in the presence of the Consultants' representatives who choose to attend. The name of the Consultants, and the technical scores of the Consultants shall be read aloud. The Financial Proposal of the Consultants who met the minimum qualifying mark will then be inspected to confirm that they have remained sealed and unopened. These Financial Proposals shall then be opened, and the total prices read aloud and recorded. Copy of the record shall be sent to all Consultants.
- 5.5 The Evaluation Committee will correct any computational errors in the Financial Proposals. When correcting computational errors, in case of discrepancy between a partial amount and the total amount the partial amount will prevail, or between word and figures the amount in words will prevail. In addition to the above corrections, as indicated under paragraph 3.6, activities and items described in the Technical Proposal but not priced, shall be assumed to be included in the prices of other activities or items. In case an activity or line item is quantified in the Financial Proposal differently from the Technical Proposal, no

corrections are applied to the Financial Proposal in this respect.

- 5.6 The lowest evaluated Financial Proposal (Fm) will be given the maximum financial score (Sf) of 100 points. The financial scores (Sf) of the other Financial Proposals will be computed as indicated in the Data Sheet. Proposals will be ranked according to their combined technical (St) and financial (Sf) scores using the weights (T = the weight given to the Technical Proposal; P = the weight given to the Financial Proposal; T + P = 1) indicated in the Data Sheet:  $S = St \times T\% + Sf \times P\%$ . The firm achieving the highest combined technical and financial score will be invited for contract negotiations.

## **6. Negotiations**

- 6.1 Negotiations will be held at the date and address indicated in the Data Sheet. The invited Consultant will, as a pre-requisite for attendance at the negotiations, confirm availability of all Professional staff indicated in its Proposal. Failure in satisfying such requirements may result in the OUR proceeding to negotiate with the next highest ranked Consultant. Representatives conducting negotiations on behalf of the Consultant must have written authority to negotiate and conclude a Contract.

### **Technical negotiations**

- 6.2 Negotiations will include a discussion of the Technical Proposal, the proposed technical approach and methodology, work plan, and organization and staffing, and any suggestions made by the Consultant to improve the Terms of Reference. The OUR and the Consultants will finalize the Terms of Reference, staffing schedule, work schedule, logistics, and reporting. These documents will then be incorporated in the Contract as "Description of Services". Special attention will be paid to clearly defining the inputs and facilities required from the OUR to ensure satisfactory implementation of the assignment. The OUR shall prepare minutes of negotiations which will be signed by the OUR and the Consultant.

### **Financial negotiations**

- 6.3 It is the responsibility of the Consultant, before starting financial negotiations, to contact the local tax authorities to determine the local tax amount, if any, to be paid by the Consultant under

the Contract. The financial negotiations will include a clarification (if any) of the firm's tax liability in Jamaica, and the manner in which it will be reflected in the Contract; and will reflect the agreed technical modifications in the cost of the services. Unless there are exceptional reasons, the financial negotiations will involve neither the remuneration rates for staff nor other proposed unit rates.

| <b>Availability of Professional staff/experts</b> | 6.4 | Having selected the Consultant on the basis of, among other things, an evaluation of proposed Professional staff, the OUR expects to negotiate a Contract on the basis of the Professional staff named in the Proposal. Before contract negotiations, the OUR will require assurances that the Professional staff will be actually available. The OUR will not consider substitutions during contract negotiations unless both parties agree that undue delay in the selection process makes such substitution unavoidable or for reasons such as death or medical incapacity. If this is not the case and if it is established that Professional staff were offered in the Proposal without confirming their availability, the Consultant may be disqualified. Any proposed substitute shall have equivalent or better qualifications and experience than the original candidate and be submitted by the Consultant within the period of time specified in the letter of invitation to negotiate. |
| <b>Conclusion of the negotiations</b>             | 6.5 | Negotiations will conclude with a review of the draft Contract. To complete negotiations the OUR and the Consultant will initial the agreed Contract. - 1 Delete items that are not applicable or add other items according to Paragraph Reference 3.6 of the Data Sheet.
- 2 Indicate unit cost.
- 3 Indicate route of each flight, and if the trip is one- or two-way.

## Section 5. Terms of Reference

### Consultancy for the Conduct of an Assessment of Competition in the Supply of Electronic Communication Services

#### A. BACKGROUND

##### A.1 Introduction

- A.1.1 The Office of Utilities Regulation (OUR) wishes to engage the services of a suitably qualified Consultant to undertake a comprehensive assessment of competition in the supply of fixed and mobile voice telephony and data services in Jamaica.
- A.1.2 The regulation of the telecommunications sector in Jamaica is apportioned to three separate organisations, the OUR, Fair Trading Commission (FTC), and Spectrum Management Authority (SMA).
- A.1.3 The OUR was established by an Act of Parliament in 1995 to regulate the operations of utility companies as specified in the First Schedule of the Office of Utilities Regulation Act (OUR Act). The OUR commenced operations in 1997. The OUR, is the primary regulator of the sector responsible for implementing the provisions of the Telecommunications Act 2000, (hereinafter referred to as “the Act”). The OUR is the entity charged with assessing market conditions and industry needs. The OUR also evaluates and determined the terms and conditions of interconnections agreements, the nature and scope of retail price regulation amongst other ex-ante measures or obligations and must ensure that such measures or obligations remains relevant, fit for purpose and consistent with the provisions of the Telecommunications Act.
- A.1.4 The FTC is responsible for promoting competition in all economic sectors and ensuring that consumers are protected from anti-competitive practices. Chief among these practices with regards to the telecommunications sector is the abuse of dominance. Pursuant to the Telecommunications Act the OUR may refer matters to the FTC where the OUR determines that the matter falls within the functions of the FTC.
- A.1.5 The SMA has responsibility for overseeing all spectrum related activity including band planning and frequency allocation, monitoring of the spectrum and inspection of facilities, interference management, enforcement to preserve the spectrum rights of all existing legitimate users of the spectrum, and spectrum related licensing management.

## A.2 Legal Framework

A.2.1 The OUR derives its mandate to regulate the provision of utility services in Jamaica from the OUR Act.

A.2.2 The OUR's general power to regulate these sectors is set out in the OUR Act, however, the OUR also has specific powers and functions in relation to the regulation of the telecommunications sector under the Telecoms Act.

A.2.3 The legal framework governing all aspects of interconnection between telecommunications service providers is set out at Sections 27 to 37 inclusive of said Telecoms Act. Under section 27 of the Telecoms Act, a dominant public telecommunications carrier is

*"a public telecommunications carrier that holds a dominant position in the telecommunications market in Jamaica within the meaning of section 19 of the Fair Competition Act;"*.

A.2.4 Section 19 of the Fair Competition Act ("FCA") states:

*"For the purposes of this Act an enterprise holds a dominant position in a market if by itself or together with an interconnected company, it occupies such a position of economic strength as will enable it to operate in the market without effective constraints from its competitors or potential competitors."*

A.2.5 Section 28 of the Telecoms Act covers the determination of dominance and states:

*"(1) Subject to subsection (2), the Office shall determine which public telecommunications carriers are to be classified as dominant public telecommunications carriers for the purposes of this Act.*

*(2) Before making a determination under subsection (1), the Office shall -*

- (a) invite submissions from members of the public on the matter; and*
- (b) consult with the Fair Trading Commission and take account of any recommendations made by that Commission.*

*(3) A dominant public telecommunications carrier may at any time apply to the Office to be classified as non dominant and the Office shall not make a determination in respect of that application unless it has invited submissions from members of the public on the matter and has taken account of any such submissions."*

A.2.6 Section 30 of the Telecoms Act imposes a duty on a dominant public telecommunications carrier to provide interconnection in relation to a public network in accordance with, among others, the following principles:

*30. – (1) Without prejudice to section 29, a dominant public telecommunications carrier shall provide interconnection in relation to a public network in accordance with the following principles –*

*(a) the terms and conditions under which it is provided shall be –*

*(i) on a non-discriminatory basis;*

*(ii) ...; and*

*(iii) charges shall be cost oriented and guided by the principles specified in section 33;”*

*(b) no unfair arrangements for cross subsidies shall be made; ...”.*

### **A.3 Industry Background**

A.3.1 The Jamaican telecommunications landscape has undergone significant developments over the last seventeen years. The market has gone from one controlled by a monopoly firm to a liberalised environment. Before the opening up of the market only two telecommunications licences were issued. Since then, over four hundred service providers have been licensed to operate. However, many of them there are no longer in operation.

A.3.2 At present, there are approximately 254,000 fixed line subscribers for a penetration rate in the region of 9.4%. Fixed line subscription had declined steadily over the past seven (7) years. For mobile, there are approximately 2.88 million subscribers for a penetration rate of 106.2%. Prepaid subscribers account for approximately 95% of all mobile subscribers. There are approximately 1.1 million internet subscribers for a penetration rate of 39.8%. The majority of internet subscribers (85.9%) are mobile broadband consumers.

A.3.3 The two main providers of fixed line telecommunication services are Cable and Wireless Jamaica Limited trading as LIME and Columbus Communications Jamaica Limited trading as Flow Jamaica (“Flow”). LIME operates a traditional circuit switched copper based PSTN while Flow offers its service using fibre to the curb and coaxial cable from the curb to the home. Digicel Jamaica Limited trading as Digicel also offers a fixed line telephony services using WiMAX wireless broadband technology

which is marketed to business customers. Digicel in September 2013 launched its fixed line home phone service using its GSM network. LIME is the industry leader in fixed line services with respect to market share, traffic, and revenue. With respect to fixed broadband service, there is a fairly even market share between LIME and Flow. The parent company of LIME has recently acquired the parent company of Flow. It is envisaged that there may be a merging of the networks for efficiency purposes. If this occurs, there will be concentration in fixed telephony and data markets.

A.3.4 There are two licensed mobile service providers operating in the telecommunications sector. These are Digicel and LIME. Digicel is the industry leader in mobile telephony and data services with respect to market share, traffic, and revenue.

A.3.5 Both of the existing mobile networks were found to be dominant with respect to call termination on their respective networks in 2004. Of the fixed line networks, only LIME has been found to be dominant. In 2003, LIME was found to be dominant in the following markets

- i. Fixed Access
  - a. Business access: This includes installation and rental of ordinary business lines and direct inward dialling (DID). Relocation and reconnection should also be included.
  - b. Residential access: This includes installation and rental of ordinary residential lines and direct inward dialling (DID). Relocation and reconnection should also be included.
- ii. Domestic Retail Services<sup>1</sup>
  - a. Intra-parish Calls: These are calls originating from a fixed access line (residential or business telephone) in one parish to a fixed access line in the same parish.
  - b. Inter-parish Calls: These are calls originating from a fixed access line (residential or business telephone) in one parish to a fixed access line in another parish.
  - c. Public Pay Phones
  - d. Other Domestic Retail: These include call waiting, three way dialling, call forwarding, automatic busy redial, priority ring, automatic call back, selective call rejection, selective call forwarding, directory assistance and freephone services.

---

<sup>1</sup> It should be noted that there is no longer any distinction between Intra-parish and Inter-parish call with respect to rates. Therefore, there is no longer any segregation of the data along this line. Public pay phone service is no longer offered.

- iii. International retail services
  - a. Outgoing International Calls: These are calls on a fixed access line and wholesale minutes (including sales to mobile service providers) to points outside of Jamaica.
  - b. Incoming International Calls
- iv. Fixed Network Interconnection Services
  - a. These carrier interconnection services are sold by C&WJ to other operators and downstream Businesses. They include switching, transmission, termination and other apparatus and system used in supplying telecommunications services.

A.3.6 LIME applied to be declared non-dominant in all fixed markets. No work has yet been done on that application so the findings from this process will be used to make a determination on LIME's application

## **B. PROJECT OBJECTIVE**

B.1.1 By virtue of the Telecoms Act, the OUR has the responsibility to determine which public telecommunications carriers are to be classified as dominant and put measures in place to prevent the abuse of dominant positions. The purpose of the project is to define and review all markets (retail and wholesale) for fixed, mobile, and data services over which the OUR has regulatory oversight. The Consultant will be expected to identify the competitive conditions affecting the supply of the services by assessing systematically the competitive constraints faced by suppliers of these services. Where dominance is identified, the Consultant will be expected to propose measure that should be implemented to prevent abuse of the dominant position. Such measures must be in accordance with the Telecoms Act and best practice regulation and promote the overall objectives of the Telecoms Act.

B.1.2 In undertaking an assessment of this type, the Consultant is required to set out its proposed Methodology. The OUR generally follows a methodological approach that is consistent with the guidelines of the European Commission (EC) on market analysis and the assessment of significant market power for electronic communications networks. It is expected that the Consultant's proposed methodology will be broadly consistent with the EC's guidelines.

B.1.3 Although the OUR has, in past assessments of the market, identified markets and which operators were dominant in those markets, it should not be taken for granted that these markets or dominance in these markets remain the same. The OUR most recent market assessment was concluded in 2003 and 2004 and the telecommunications sector has substantial changed since that time. As such, market

definitions and dominant positions may have changed since the last market assessment.

## **C. SCOPE OF SERVICES**

### **C.1 Consumer Survey**

C.1.1 The Consultant will be required to engage the service of a suitably qualified local research firm to conduct a market survey. The cost for this engagement should be factored in the Consultant's bid price. The Consultant does not need to seek the approval of the OUR in selecting the local research company. However, the OUR expects that its input will be sought in the formulation of the questions to be asked in the market survey. The Consultant will be expected to analyse the results of the survey so that it can be used to inform/support the positions to be taken in the Consultation Document on the issue of dominance.

### **C.2 Consultation Document**

C.2.1 The Consultant will be expected to undertake consultations with interested stakeholders on the principles, methodology, and guidelines which will influence the decision as to what constitutes a market and which operators hold dominant positions in those markets. It is expected that the Consultant will examine both the retail and wholesale side of the business. Prior to drafting the Consultation Document, the Consultant should collect and collate the data/evidence required for the analysis. In some cases, the OUR may have data which will be made available to the Consultant. In other cases, the Consultant should prepare a data request for the operators which the OUR will administer. Another source of data will be information gathered from the consumer survey. The data to be collected should include the following:

- ❖ Market share data (sales value and volume);
- ❖ Product functionality;
- ❖ Prices and costs;
- ❖ Inputs;
- ❖ Substitute products
- ❖ Principal competitors; and
- ❖ Market entry conditions.

C.2.2 In general, the consultation document should discuss the following areas

- The relevant market
  - Product market
    - Demand side substitution
    - Supply side substitution

- Geographic market
- Determination of dominance
  - Market share and concentration
  - Barriers to entry
  - Buyer power
  - Pricing behaviour
  - Vertical relationships

### C.3 **Decision Document**

C.3.1 As a result of the consultation with stakeholders, comments on the consultation document will likely be received regarding the principles and methodology used in defining the markets and the resultant position with respect to dominance in those markets. The Consultant will be expected to evaluate the comments received and prepare a response document which will form the basis of the OUR's definitive position.

### C.4 **Document on Regulatory Options**

C.4.1 Where there has been a finding of dominance, the Consultant shall prepare a document to advise the OUR as to whether regulatory intervention is needed to correct or prevent abuse of the dominant position. Where intervention is deemed necessary, the Consultant should also provide advice as to the likely regulatory measure that can be implemented by the OUR. The suggested corrective measures should accord with the powers afforded to the OUR under the Telecoms Act.

## D.1 **TEAM COMPOSITION**

D.1.1 The composition of the Consultant team is expected to have the following ###(3) functional roles. The Consultant may indicate more or less than 3 persons as they desire. However, scoring will be based on the 3 functional areas identified. The Consultant may indicate in their bid that a particular function will to be carried out by more than one person or that one person will carry out more than one function. The scoring will however depend on the ability and experience of the named person(s) to carry out the specific function.

- 1) **Team Leader** – is the project manager with overall reporting responsibility to the OUR (the Client). The team leader is charged with coordinating the activities of the rest of the team to ensure the successful completion of the project. This person will be the Client's point of contact/liaison and will be responsible for providing updates on the project's progress.
- 2) **Industry Analyst #1** – should have the relevant qualification and experience to assess the current state of the industry and the existing regulatory

environment so as to make appropriate conclusions as to what constitutes a market and the level of effective competition within those markets.

- 3) **Industry Analyst # 2** – should have the relevant qualification and experience to assess the current state of the industry and the existing regulatory environment so as to make appropriate conclusions as to what constitutes a market and the level of effective competition within those markets.

## **E.1 PHASES/DELIVERABLES**

- E.1.1 The consultancy is expected to have three (3) distinct phases each with its own set of deliverables. In the First Phase, the Consultant shall engage the services of a local research company to carry out the consumer survey. The Consultant shall analyse the results of the survey and present the findings to the OUR. The OUR also expects to be given a copy of the survey raw data. The results will be used to inform some of the positions which will be taken in the Consultation Document. The Consultant will also collect other relevant data from the OUR and stakeholders as needed for the project.
- E.1.2 In the Second Phase, using the data collected, the Consultant will prepare the Consultation Document which the OUR will share with stakeholders for discussion.
- E.1.3 In the Third Phase, the Consultant will use the responses received from stakeholders to the Consultation Document to prepare a document which will constitute the OUR's final position on the matter. This will be the Decision Document. The Consultants will also prepare a separate document on the regulatory options available to the OUR to prevent or correct the abuse of dominance in the various markets.
- E.1.4 It should be noted that Consultant may propose a different phasing for the project with justification to support the suggested changes.

## **F.1 TIME SCHEDULE**

- F.1.1 The OUR anticipates that this consultancy will last for at most nine (9) months to be broken down as indicated. It should be noted that the OUR process for consulting with stakeholders allows for a minimum of 4 weeks to respond to the Consultation Document and a minimum of another 2 weeks to comment on responses to the Consultation Document.

- Phase 1 – Consumer survey and data gathering → 3 months
- Phase 2 – Consultation with stakeholders → 4 months

- Phase 3 – Prepare decision and regulatory options document  
→ 2 months

## II. General Conditions of Contract

### 1. GENERAL PROVISIONS

#### 1.1 Definitions

Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- a. **“Applicable Law”** means the laws and any instruments having the force of law in Jamaica.
- b. **“Consultant”** means [*insert names*] of Consultant].
- c. **“Contract”** means the Form of Contract signed by the Parties and all the attached documents listed in its Clause 1, that is, these General Conditions (GC), the Special Conditions (SC), and the Appendices.
- d. **“Contract Price”** means the price to be paid for the performance of the Services, in accordance with Clause 6;
- e. **“Effective Date”** means the date on which this Contract comes into force and effect pursuant to Clause GC 2.1.
- f. **“Foreign Currency”** means any currency other than the currency of Jamaica.
- g. **“GC”** means these General Conditions of Contract.
- h. **“Government”** means the Government of Jamaica.
- i. **“Local Currency”** means the currency of Jamaica.
- j. **“Member”** means any of the entities that make up the joint venture/consortium/association comprising the Consultant, and **“Members”** means all of these entities.
- k. **“Party”** means the OUR or the Consultant, as the case may be, and **“Parties”** means both of them.

- l. **“Personnel”** means persons hired by the Consultant or by any Sub-Consultants and assigned to the performance of the Services or any part thereof.
- m. **“SC”** means the Special Conditions of Contract by which the GC may be amended or supplemented.
- n. **“Services”** means the work to be performed by the Consultant pursuant to this Contract, as described in Appendix A hereto.
- o. **“Sub-Consultants”** means any person or entity to whom/which the Consultant subcontracts any part of the Services.
- p. **“Tax Compliance Certificate”** means a document issued by the Ministry with portfolio responsibility for finance in Jamaica to an individual or company as proof that the Jamaican tax liabilities and wage related statutory deductions of that individual or company have been duly paid.
- q. **“Third Party”** means any person or entity other than the OUR, the Consultant or a Sub-Consultant.
- r. **“In writing”** means communicated in written form.

**1.2 Law Governing Contract** This Contract, its meaning and interpretation, and the relationship between the Parties shall be governed by the Applicable Law.

**1.3 Language** This Contract has been executed in the English language, which shall be the binding and controlling language for all matters relating to the meaning or interpretation of this Contract.

**1.4 Notices**

**1.4.1** Any notice, request or consent required or permitted to be given or made pursuant to this Contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the address specified in the SC.

- 
- 1.4.2** A Party may change its address for notice hereunder by giving the other Party notice in writing of such change to the address specified in the SC.
- 1.5 Location** The Services shall be performed at such locations as are specified in Appendix A hereto and, where the location of a particular task is not so specified, at such locations, as the OUR may approve.
- 1.6 Authority of Member in Charge** In case the Consultant consists of a joint venture/ consortium/ association of more than one entity, the Members hereby authorize the entity specified in the SC to act on their behalf in exercising all the Consultant's rights and obligations towards the OUR under this Contract, including without limitation the receiving of instructions and payments from the OUR.
- 1.7 Authorized Representatives** Any action required or permitted to be taken, and any document required or permitted to be executed under this Contract by the OUR or the Consultant may be taken or executed by the officials specified in the SC.
- 1.8 Taxes and Duties** The Consultant, Sub-Consultants, and their Personnel shall pay such taxes, duties, fees, and other impositions levied under the Applicable Law as specified in the SC, the amount of which is deemed to have been included in the Contract Price. For the duration of this Contract, the Consultant shall demonstrate that it has paid all applicable taxes, duties, fees and other impositions as may be levied in Jamaica by the submission to the OUR of a valid Tax Compliance Certificate whenever requested by the OUR.
- 1.9 Fraud and Corruption**
- 1.9.1 Definitions** The OUR requires that its bidders, suppliers, contractors and consultants observe the highest standard of ethics during the procurement and execution of its contracts. In pursuit of this policy, the OUR:
- (a) defines, for the purpose of this provision, the terms set forth below as follows:
- (i) **"corrupt practice"** means the offering, giving,

receiving, or soliciting, directly or indirectly, of anything of value to influence the action of an officer or servant of the OUR in the procurement process or in contract execution;

(ii) “**fraudulent practice**” means a misrepresentation or omission of facts in order to influence a procurement process or the execution of a contract, to the detriment of the OUR and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the OUR of the benefits of free and open competition;

(iii) “**collusive practice**” means a scheme or arrangement between two or more bidders, with or without the knowledge of the OUR, designed to establish bid prices at artificial non-competitive levels or to influence the action of any party in the procurement process or the execution of a contract; and

(iv) “**coercive practice**” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of a contract.

- 1.9.2 Commissions and Fees** The OUR requires the Consultant to disclose any commissions or fees that may have been paid or are to be paid to agents, representatives, or commission agents with respect to the selection process or execution of the contract. The information disclosed must include at least the name and address of the agent, representative, or commission agent, the amount and currency, and the purpose of the commission or fee.

---

## 2. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT

- 2.1 Effectiveness of Contract** This Contract shall come into effect on the date the Contract is signed by both Parties or such other later date as may be stated in the SC. The date the Contract comes into effect is defined as the Effective Date.
- 2.2 Commencement of Services** The Consultant shall begin carrying out the Services not later than the number of days after the Effective Date specified in the SC.
- 2.3 Expiration of Contract** Unless terminated earlier pursuant to Clause GC 2.6 hereof, this Contract shall expire at the end of such time period after the Effective Date as specified in the SC.
- 2.4 Modifications or Variations** Any modification or variation of the terms and conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties.
- 2.5 Force Majeure**
- 2.5.1 Definition** For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party and which makes a Party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.
- 2.5.2 No Breach of Contract** The failure of a Party to fulfill any of its obligations under this Contract shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event (a) has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and (b) has informed the other Party as soon as possible about the occurrence of such an event.
- 2.5.3 Extension of Time** Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

**2.5.4 Payments** During the period of its inability to perform the Services as a result of an event of Force Majeure, the Consultant shall not be entitled to payment under the terms of this Contract, except for the OUR's payment liabilities incurred prior to the said suspension of the Contractor's performance of the Services. On resumption of the Consultant's performance of the Services, the OUR's obligation to make payments under the terms of this Contract shall also resume.

## **2.6 Termination**

**2.6.1 By the OUR** The OUR may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (f) of this Clause GC 2.6.1. With the exception of the event referred to in paragraph (f) of this Clause 2.6.1, the OUR shall give not less than thirty (30) days' written notice of termination to the Consultant. The OUR shall give not less than sixty (60) days' written notice in the case of the event referred to in paragraph (f) of this Clause 2.6.1.

- (a) If the Consultant does not remedy a failure in the performance of its obligations under the Contract, within thirty (30) days after being notified or within any further period as the OUR may have subsequently approved in writing.
- (b) If the Consultant becomes insolvent or bankrupt.
- (c) If the Consultant, in the judgment of the OUR has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
- (d) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) days.
- (e) If the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause GC 8 hereof.
- (f) If the OUR, in its sole discretion and for any reason whatsoever, decides to terminate this Contract.

- 
- 2.6.2 By the Consultant** The Consultant may terminate this Contract, by not less than thirty (30) days' written notice to the OUR, such notice to be given after the occurrence of any of the events specified in paragraphs (a) through (c) of this Clause GC 2.6.2:
- (a) If the OUR fails to pay any money due to the Consultant pursuant to this Contract and not subject to dispute pursuant to Clause GC 8 hereof within forty-five (45) days after receiving written notice from the Consultant that such payment is overdue.
  - (b) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) days.
  - (c) If the OUR fails to comply with any final decision reached as a result of arbitration pursuant to Clause GC 8 hereof.
- 2.6.3 Payment upon Termination** Upon termination of this Contract pursuant to Clauses GC 2.6.1 or GC 2.6.2, the OUR shall make the following payments to the Consultant:
- (a) payment pursuant to Clause GC 6 for Services satisfactorily performed prior to the effective date of termination;
  - (b) except in the case of termination pursuant to paragraphs (a) through (c), and (e) of Clause GC 2.6.1, reimbursement of any reasonable cost incidental to the prompt and orderly termination of the Contract, including, if applicable, the cost of the return travel of the Personnel and their eligible dependents.

### 3. OBLIGATIONS OF THE CONSULTANT

#### 3.1 General

**3.1.1 Standard of Performance** The Consultant shall perform the Services and carry out its obligations hereunder with all due diligence, efficiency and economy, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Contract or to the Services, as faithful advisers to the OUR, and shall at all times support and safeguard the OUR's legitimate interests in any dealings with Sub-Consultants or Third Parties.

**3.2 Conflict of Interests** The Consultant shall hold the OUR's interests paramount, without any consideration for future work, and strictly avoid conflict with other assignments or its own corporate interests.

**3.2.1 Consultants Not to Benefit from Commissions, Discounts, etc.** The payment of the Consultant pursuant to Clause GC 6 shall constitute the Consultant's only payment in connection with this Contract or the Services, and the Consultant shall not accept for its own benefit any trade commission, discount, or similar payment in connection with activities pursuant to this Contract or to the Services or in the discharge of its obligations under the Contract, and the Consultant shall use its best efforts to ensure that the Personnel, any Sub-Consultants, and agents of either of them similarly shall not receive any such additional payment.

**3.2.2 Consultant and Affiliates Not to be Otherwise Interested in Project** The Consultant agrees that, during the term of this Contract and after its termination, the Consultant and any entity affiliated with the Consultant, as well as any Sub-Consultants and any entity affiliated with such Sub-Consultants, shall be disqualified from providing goods, works or services (other than consulting services) resulting from or directly related to the Consultant's Services for the preparation or implementation of the project.

**3.2.3 Prohibition of Conflicting Activities** The Consultant shall not engage, and shall cause its Personnel as well as its Sub-Consultants and their personnel not to engage, either directly or indirectly, in any business or professional activities which would conflict with the activities assigned to them under this Contract.

- 
- 3.3 Confidentiality** Except with the prior written consent of the OUR, the Consultant and the Personnel shall not at any time communicate to any person or entity any confidential information acquired in the course of the performance of the Services, nor shall the Consultant and the Personnel make public the recommendations formulated in the course of, or as a result of, the performance of the Services.
- 3.4 Insurance to be Taken Out by the Consultant** The Consultant (a) shall take out and maintain, and shall cause any Sub-Consultants to take out and maintain, at their (or the Sub-Consultants', as the case may be) own cost but on terms and conditions approved by the Procuring Entity, insurance against the risks, and for the coverage, as shall be specified in the SC; and (b) at the Procuring Entity's request, shall provide evidence to the Procuring Entity showing that such insurance has been taken out and maintained and that the current premiums have been paid.
- 3.5 Consultant's Actions Requiring OUR's Prior Approval** The Consultant shall obtain the OUR's prior approval in writing before taking any of the following actions:
- (a) entering into a subcontract for the performance of any part of the Services;
  - (b) appointing such members of the Personnel not listed by name in Appendix C; and
  - (c) any other action that may be specified in the SC.
- 3.6 Reporting Obligations**
- (a) The Consultant shall submit to the OUR the reports and documents specified in Appendix B hereto, in the form, in the numbers and within the time periods set forth in the said Appendix.
  - (b) Final reports shall be delivered in CD ROM in addition to the hard copies specified in the said Appendix B.
- 3.7 Documents Prepared by the Consultant to be the Property of the OUR**
- (a) All plans, drawings, specifications, designs, reports, other documents and software submitted by the Consultant under this Contract shall become and remain the property of the OUR, and the Consultant shall, not later than upon termination or expiration of this Contract, deliver all such documents to the OUR, together with a detailed inventory thereof.

- (b) The Consultant may retain a copy of such documents and software. Restrictions about the future use of these documents, if any, shall be specified in the SC.

**3.8 Accounting, Inspection and Auditing**

The Consultant (i) shall keep accurate and systematic accounts and records in respect of the Services hereunder, in accordance with internationally accepted accounting principles and in such form and detail as will clearly identify all relevant time, charges and costs, and the bases thereof, and (ii) shall periodically permit the OUR or its designated representative and up to two years from the expiration or termination of this Contract, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by the OUR, if so required by the OUR.

**4. CONSULTANT'S PERSONNEL**

**4.1 Description of Personnel**

The Consultant shall employ and provide such qualified and experienced Personnel and Sub-Consultants as are required to perform the Services. The titles, agreed job descriptions, minimum qualifications, and estimated periods of engagement in the performance of the Services of the Consultant's Key Personnel are described in Appendix C. The Key Personnel and Sub-Consultants listed by title as well as by name in Appendix C are hereby approved by the OUR.

**4.2 Removal and/or Replacement of Personnel**

- (a) Except as the OUR may otherwise agree, no changes shall be made in the Key Personnel. If, for any reason beyond the reasonable control of the Consultant, such as retirement, death, medical incapacity, among others, it becomes necessary to replace any of the Key Personnel, the Consultant shall provide as a replacement a person of equivalent or better qualifications.
- (b) If the OUR finds that any of the Personnel have (i) committed serious misconduct or have been charged with having committed a criminal act, or (ii) have reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultant shall, at the OUR's written request specifying the grounds thereof, replace such person with a person possessing qualifications and experience acceptable to the OUR.

- (c) The Consultant shall have no claim for additional costs arising out of or incidental to any removal and/or replacement of Personnel.

## **5. OBLIGATIONS OF THE OUR**

- 5.1 Change in the Applicable Law Related to Taxes and Duties** If, after the date of this Contract, there is any change in the Applicable Law with respect to taxes and duties which increases or decreases the cost incurred by the Consultant in performing the Services, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Contract shall be increased or decreased accordingly by agreement between the Parties, and corresponding adjustments shall be made to the amounts referred to in Clauses GC 6.2 (a) or (b), as the case may be.
- 5.2 Services and Facilities** The OUR shall make available free of charge to the Consultant the Services and Facilities listed under Appendix F.

## **6. PAYMENTS TO THE CONSULTANT**

- 6.1 Lump-Sum Payment** The total payment due to the Consultant shall not exceed the Contract Price which is an all inclusive fixed lump-sum covering all costs required to perform the Services described in Appendix A. Except as provided in Clause 5.1, the Contract Price may only be increased above the amounts stated in Clause 6.2 if the Parties have agreed to additional payments in accordance with Clause 2.4.
- 6.2 Contract Price**
- (a) The price payable in foreign currency/currencies is set forth in the SC.
- (b) The price payable in local currency is set forth in the SC.
- 6.3 Payment for Additional Services** For the purpose of determining the remuneration due for additional services as may be agreed under Clause 2.4, a breakdown of the lump-sum price is provided in Appendices D and E.
- 6.4 Terms and Conditions of Payment** Payments will be made to the Consultant according to the payment schedule stated in the SC. Unless otherwise stated in the SC, the first payment shall be made against the provision by the Consultant of an advance payment guarantee for the same amount, and shall be valid

for the period stated in the SC. Such guarantee shall be in the form set forth in Appendix G hereto, or in such other form, as the OUR shall have approved in writing. Any other payment shall be made after the conditions listed in the SC for such payment have been met, and the Consultant has submitted an invoice to the OUR specifying the amount due.

## **7. GOOD FAITH**

- 7.1 Good Faith** The Parties undertake to act in good faith with respect to each other's rights under this Contract and to adopt all reasonable measures to ensure the realization of the objectives of this Contract.

## **8. SETTLEMENT OF DISPUTES**

- 8.1 Amicable Settlement** The Parties agree that the avoidance or early resolution of disputes is crucial for a smooth execution of the Contract and the success of the assignment. The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or its interpretation.
- 8.2 Dispute Resolution** Any dispute between the Parties as to matters arising pursuant to this Contract that cannot be settled amicably within thirty (30) days after receipt by one Party of the other Party's request for such amicable settlement may be submitted by either Party for settlement in accordance with the provisions specified in the SC.
