- (4) Qualified organizations include telecommunications carriers/service providers, the Fair Trading Commission, and organizations representing the interest of users of communication services.
- (5) The OUR will also invite individual users of telecommunications services. Interested users will be asked to respond to a public notice to be posted in a daily newspaper of general circulation.
- (6) Presenters are required to focus on issues related to the Office's proposed decision on the OUR's information requirements from telecommunications licensees (Advance Notice of Reconsideration Decision: Application for Reconsideration of Determination Notice (TEL 2004/04) on "Telecommunications Markets Information Requirements").
- (7) Arguments filed by May 10, 2005 should be detailed, and include all relevant facts.
- (8) The Forum will be held at the PCJ Auditorium, 36 Trafalgar Road., Kingston 10.

- (3) Each licensee making an oral presentation is required to file a detailed written submission with the OUR by May 10, 2005 in electronic format (Microsoft Word). Each presenter will be allocated 20 minutes for their presentation.
- (4) Written statements by other participants may be submitted by May 10, 2005 for consideration in the proceedings. Such statements will be posted on the OUR's website.
- (5) Other participants will have an opportunity to state (for the record) their views and information needs. Members of the public may also make written submissions for the Office's consideration, before it makes a final decision on this matter.
- (6) Statements (written or oral) must focus on issues related to the proposed information requirements decision.
- (7) Participants are asked to respect the rights of other participants to be heard and fully participate in the proceedings.
- (8) Each licensee's presentation will be followed by a question and answer session.
- (9) In each question and answer session, the OUR will ask questions followed by other participants.
- (10) When asking questions or making comments, each participant is required to state his/her name and organization for the record.
