# TERMS OF REFERENCE – FOR THE PROVISION OF SPECIALIST CONSULTANCY SERVICES

#### 1. Introduction

The Office of Utilities Regulation (OUR) is a non-profit organization which was established by the Office of the Utilities Act, 1995 (OUR Act). The organization is charged with the responsibility of regulating the provision of utility services in the Electricity, Telecommunications and Water & Sewerage sectors:

#### Mission

The mission of the OUR is "To contribute to national development by creating an environment for the efficient delivery of utility services to the customers, whilst assuring that the Service Providers have the opportunity to make a reasonable return on their investments".

The OUR is required to conform to the Government's Procurement Guidelines including those established by the National Contracts Commission (NCC), in procuring goods and services. Given the nature of the OUR's operations, from time to time it is required be engaged in activities for which the resources may not exists within the organization or the exigencies of its work timetable dictate the need for additional resources. In such instances, it is usually necessary to obtain the services of specialist consultants to provide professional advice, perform technical tasks or to undertake such assignments as will assist the OUR in conducting special analyses, making regulatory determinations or resolving disputes. In an effort to meet these needs, the organization has established a Register of Pre-approved Specialist Consultants who may be contracted to provide specialist/expert services.

The Register of Pre-approved Specialist Consultants will be periodically revised, at which time, existing consultants can update their service portfolio and additional applications for inclusion on the Register will be accepted, evaluated and suitably qualified individuals or firms selected and added. While not guaranteeing specific works to these experts, the arrangement will allow the OUR to access definitive expert services in specialist areas as required at pre-determined rates and in a timely manner.

The OUR therefore invites individuals or firms of professional consultants to submit a "Request for Preapproval – Register of Pre-approved Specialist Consultants" in specialized disciplines which may include but are not limited to the following areas:

### 2. Objective

The objective of this Request for Pre-approval in the skills sets outlined above and any other related to the regulation of the relevant sectors is to update the OUR's Register of Pre-approved Specialist Consultants. This Register is a catalogue of suitably qualified professional consultants who possess requisite specialist knowledge and competence in specific areas of the regulated utility sectors, viz – telecommunications, electricity/energy and water and sewerage.

#### 3. Services To Be Provided

These specialist consultants will be contracted to undertake assignments that are time sensitive or require specialist knowledge or expertise for their execution. These assignments include system and commercial operational issues, and strategic business related matters.

### 4. Eligible Applicants

The request for pre-approval of specialist consultants is open to independent professional consultants. The specialist consultants shall include, but not be limited to areas indicated above. At the time of submission, applicants shall be required to meet the following minimum criteria:

- a. Be registered with the relevant local professional bodies to provide services where it is a requirement of the Profession;
- b. Must be in possession of a valid Tax Compliance Certificate (TCC);
- c. Must be willing to sign a confidentiality agreement, thereby agreeing to observe in strictest confidence all information on the operations of the organization's regulatory functions to which you may be exposed in the execution of the consultancy services;
- d. Must be willing to adhere to the OUR's policy as it relates to Copyright "The copyright of all documents specifically prepared by the Consultant as a result of his/her services rests with the OUR. The Consultant(s) may take copies of such documents, but shall not use the contents thereof for any purpose unrelated to his/her services without the prior written approval of the OUR";
- e. Must have satisfactorily completed at least three (3) significant assignments in the required area of specialty for either the OUR, or an organization of similar size and operation;
- f. In respect of (e) above; if a member of a team, the Consultant must have played a pivotal role in the execution of the significant assignment indicated;
- g. Should have at least ten (10) years working experience in the particular specialist area.

## 5. Format of Submissions

Each application shall include:

(a) A request for inclusion on the Register, indicating the particular area(s) of expertise for which inclusion is being sought;

- (b) Detailed resume outlining the applicant's academic qualification, professional society membership, complete professional experience and contact information. Each applicant must complete and submit the Summary of Qualification Form – Consultancy Services (Appendix I);
- (c) In the case of firms, the applicant must state the principals of the firm, their qualification and experience and the qualification and experience of all key personnel who may be assigned to undertake assignments with the OUR;
- (d) References from at least three (3) clients who can attest to the satisfactory performance of the applicant on assignments relevant to each specialist areas identified; and
- (e) A warranty signed by the applicant that he/she has no fiduciary interest in, or business relationship with any organization, entity or endeavor that could create a conflict of interest relating to the current or future supply of services to the OUR. Where such a relationship exists, the applicant must commit to inform the OUR of the relationship and disqualifies himself/herself from undertaking any assignment that would create a conflict.

#### 6. Submission Details

Applications must be clearly labelled, "CONFIDENTIAL: Request for Pre-approval – Specialist Consultancy Services" and submitted no later than 3:00 p.m. Eastern Standard Time on Friday, August 7, 2015 to:

#### 7. Evaluation of Applications

The applications will be evaluated to identify the individuals/firms best suited to provide the OUR with consultancy services in the area(s) of specialty. The following Evaluation Criteria will be used:

- (a) Specific Experience and Technical Competence assessment will be made of the applicant's or key personnel's track record in providing consultancy services in the specialist areas identified and the extent to which s/he possess the requisite skills and experience to effectively provide this service; and
- (b) Education/Professional Qualification assessment will be made of the applicant's training and professional certification to provide consultancy services in the relevant specialist area.

#### The following scoring system shall apply:

Consultants should designate the particular area(s) for which the expertise is being offered and each area will be evaluated on the basis outlined below

#### 8. Selection and Notification of Specialist Consultant

Only applicants scoring above **80 points** will be considered for inclusion in the Register for a particular area of expertise. The selection of applicants will be at the sole discretion of the OUR and no reason will be provided for the exclusion of any applicant. The OUR will notify the Specialist Consultant of the selection for inclusion on the Register of Pre-approved Specialist Consultants.

#### 9. Liability

The OUR shall not be responsible or liable for any costs incurred by any person in relation to this Request for Pre-Approval.
