**RE: Annual Price Adjustment Mechanism (AnPAM) Adjustment**

In fulfillment of the Office of Utilities Regulation's request for the submission of the Annual Price Adjustment Mechanism (AnPAM), we hereby set-out in detail the components of AnPAM in the table below:


	Component	Weights
Electricity	54.41	20%
Exchange Rate	157.13	18%
Consumer Price Index	118.6	62%
<b>AnPAM</b>	<b>11.70%</b>	<b>100%</b>

The AnPAM adjustment will be effective upon approval, and the new base rates and weights assigned are set out in the table above.

The National Water Commission in times past has requested to keep the reconnection fees fixed until the next Tariff Determination. However, due to increased costs faced by NWC and demands by contractors for a rate hike, we are proposing changes to the reconnection fees as set out in the rate sheet attached.

Attached is the adjusted rate sheet for your approval.
