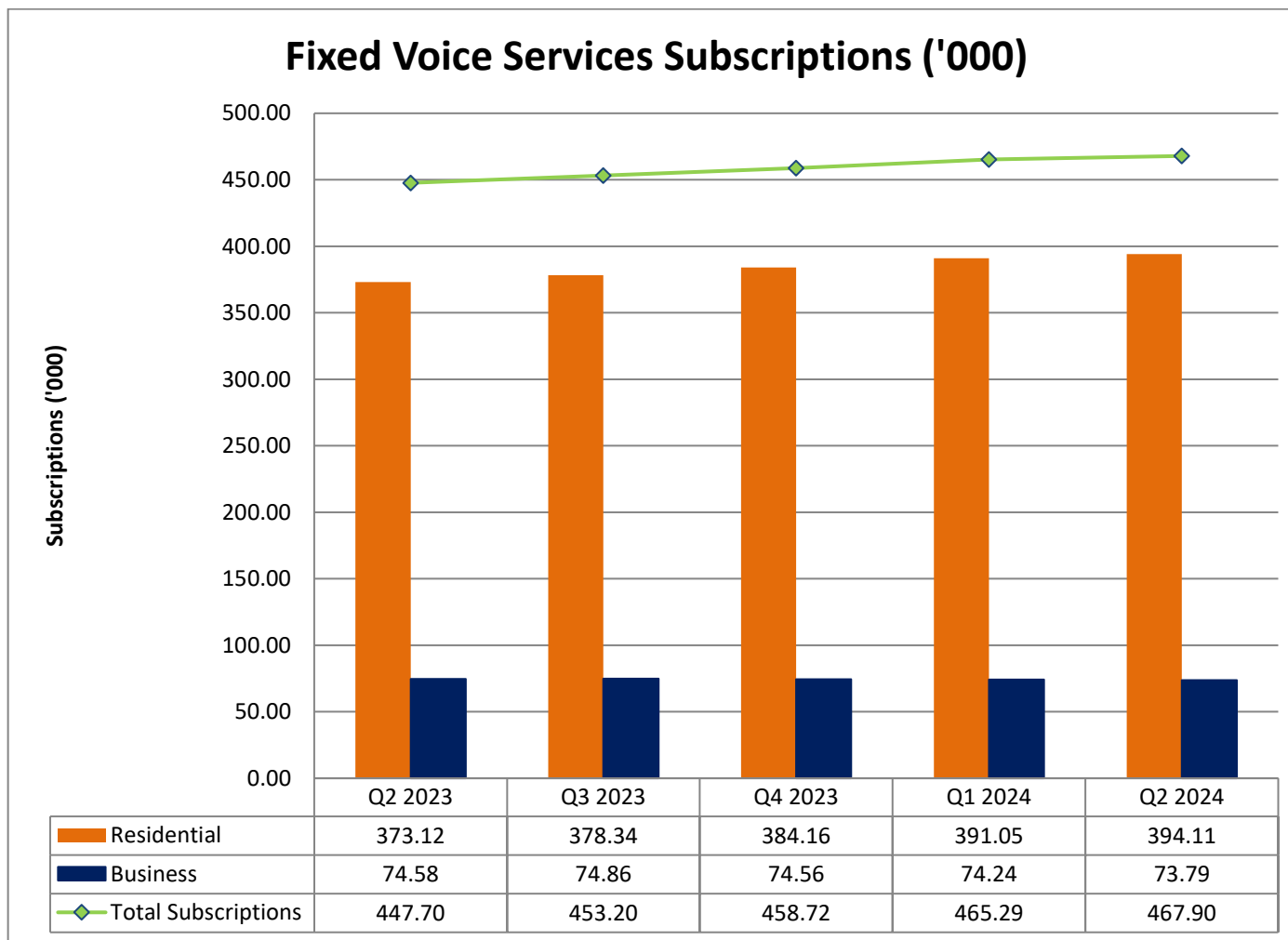

Figure 1: Fixed Voice Services Subscriptions



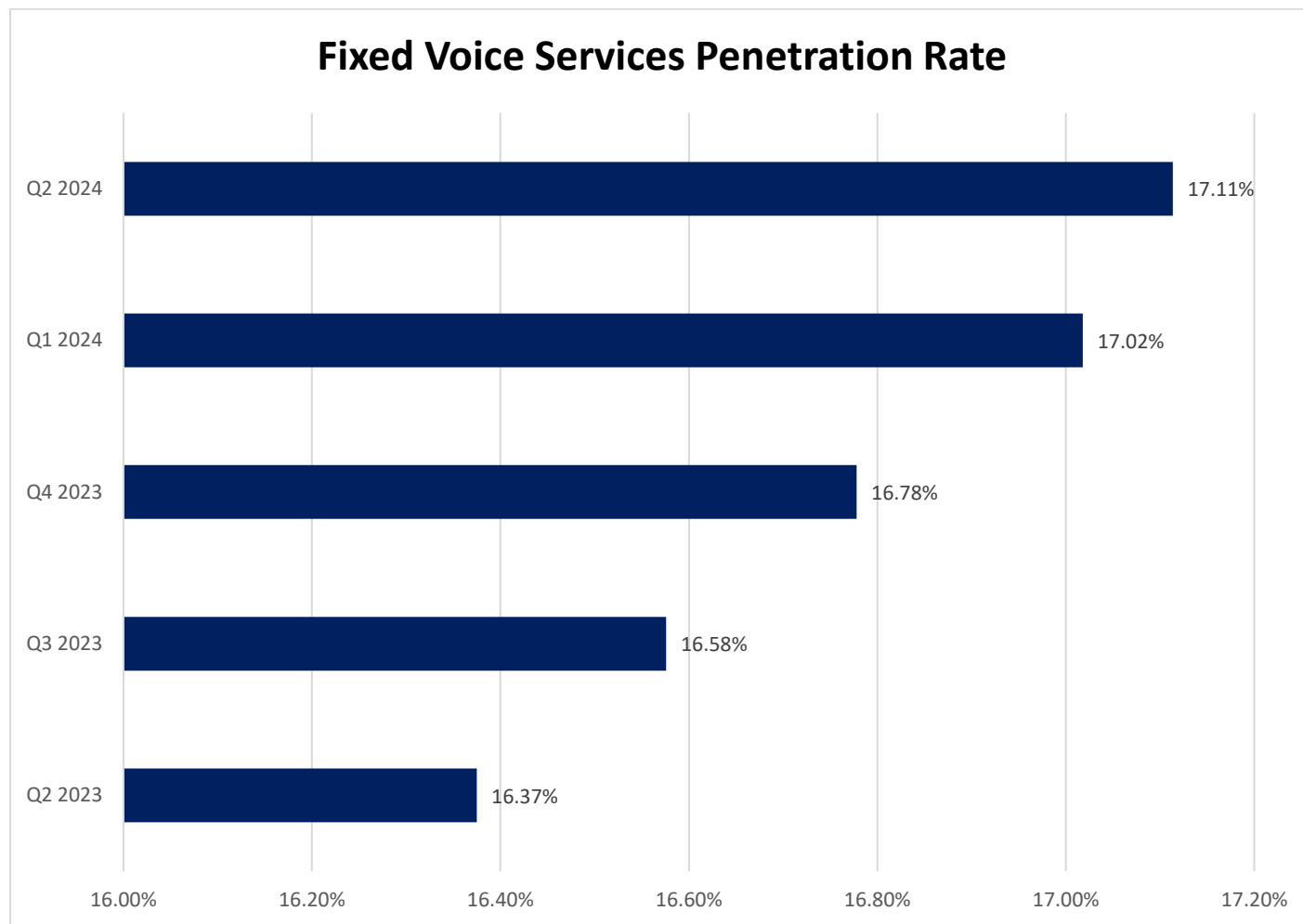

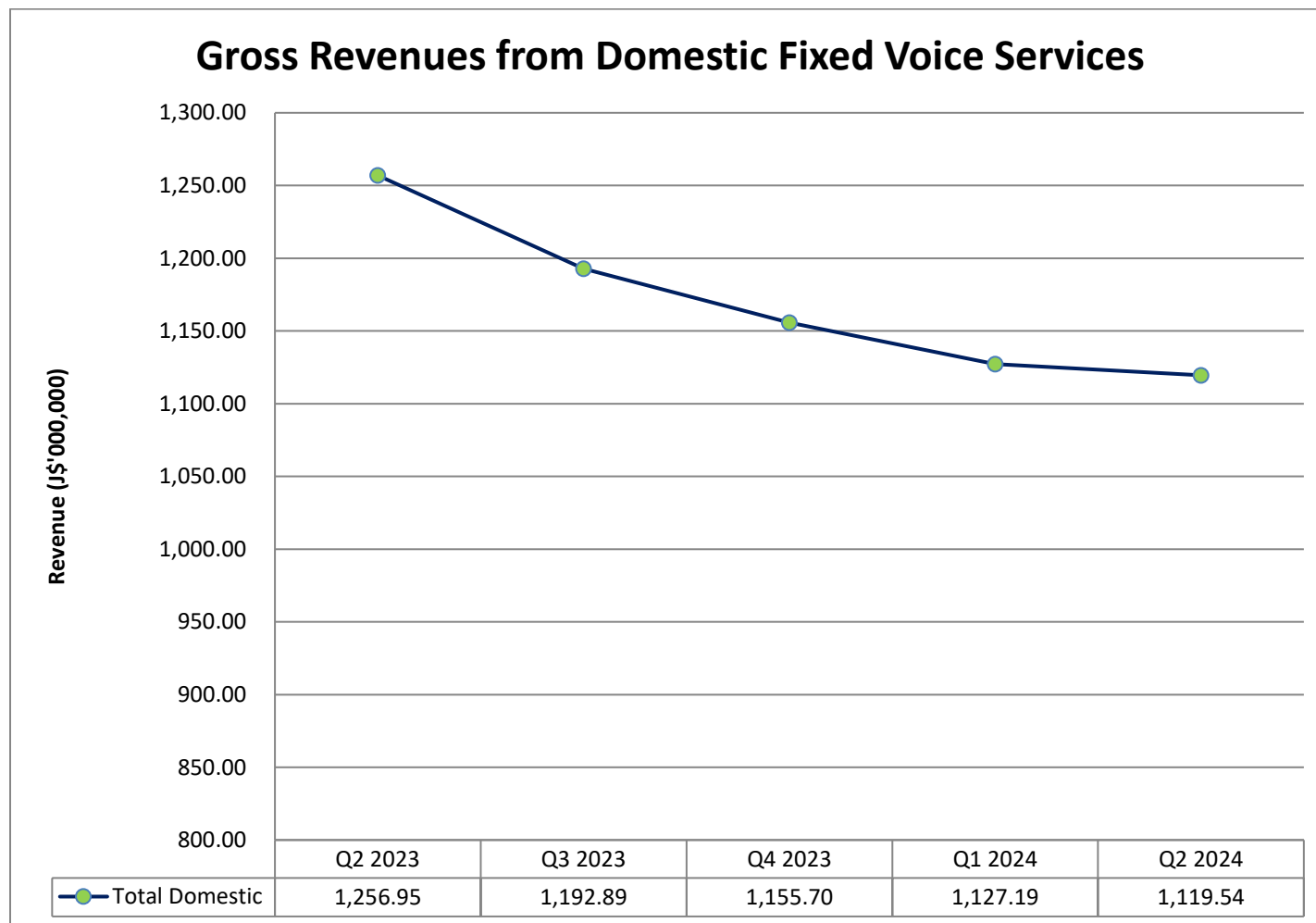

Figure 2: Fixed Voice Services Penetration Rate



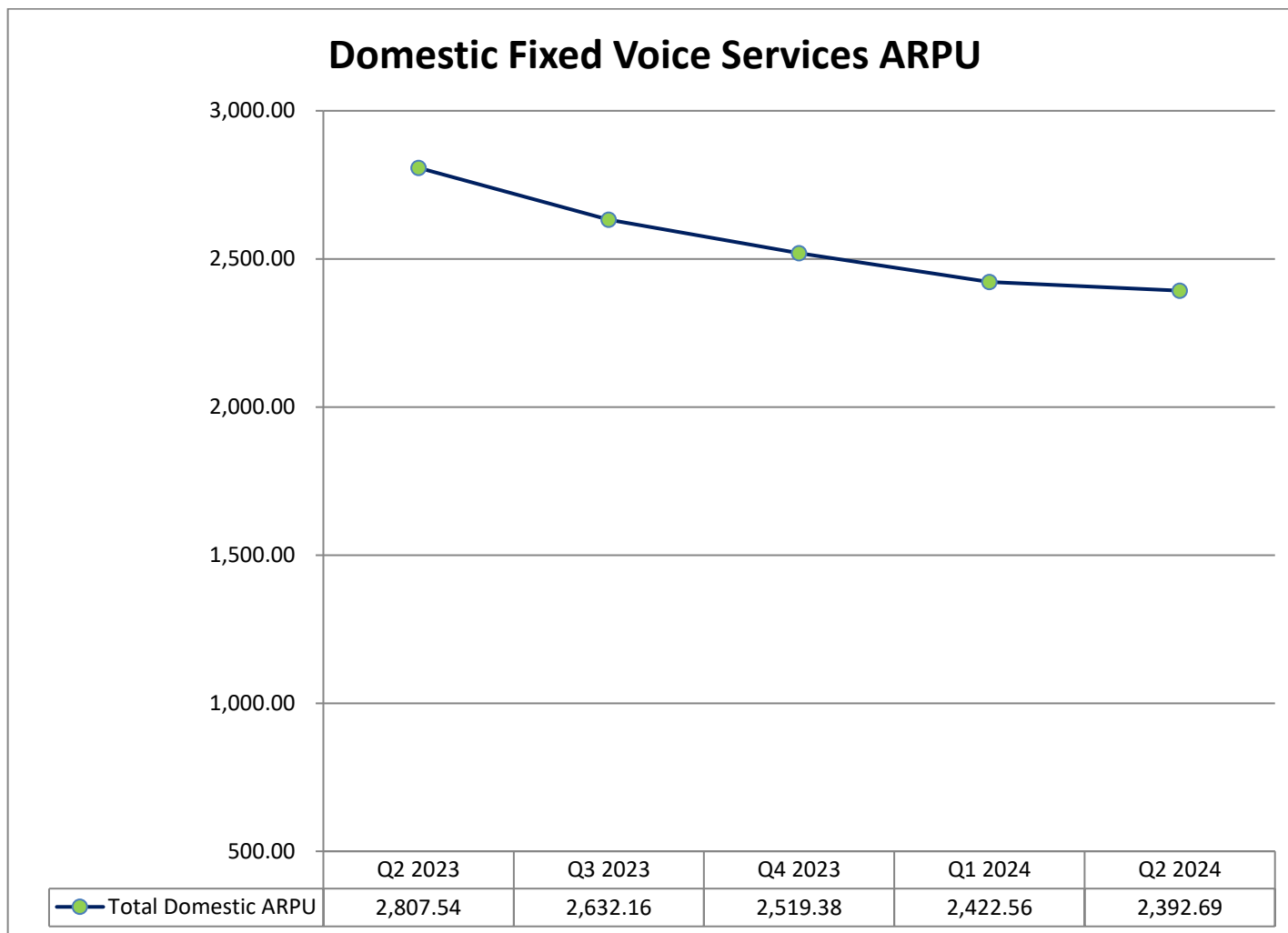

Figure 3: Gross Revenues from Domestic Fixed Voice Services



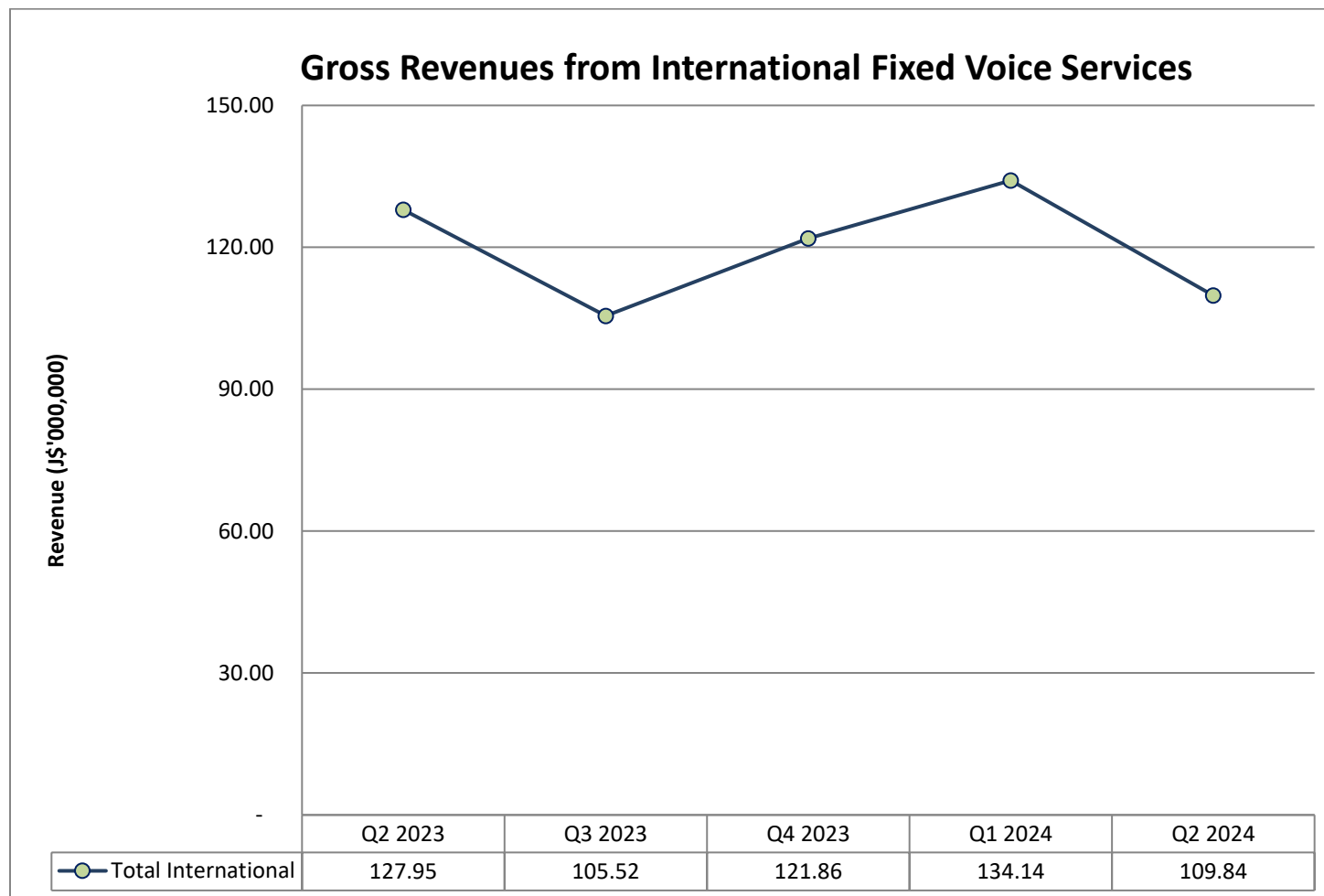

Figure 4: Domestic Fixed Voice Services Average Revenue per User (ARPU)



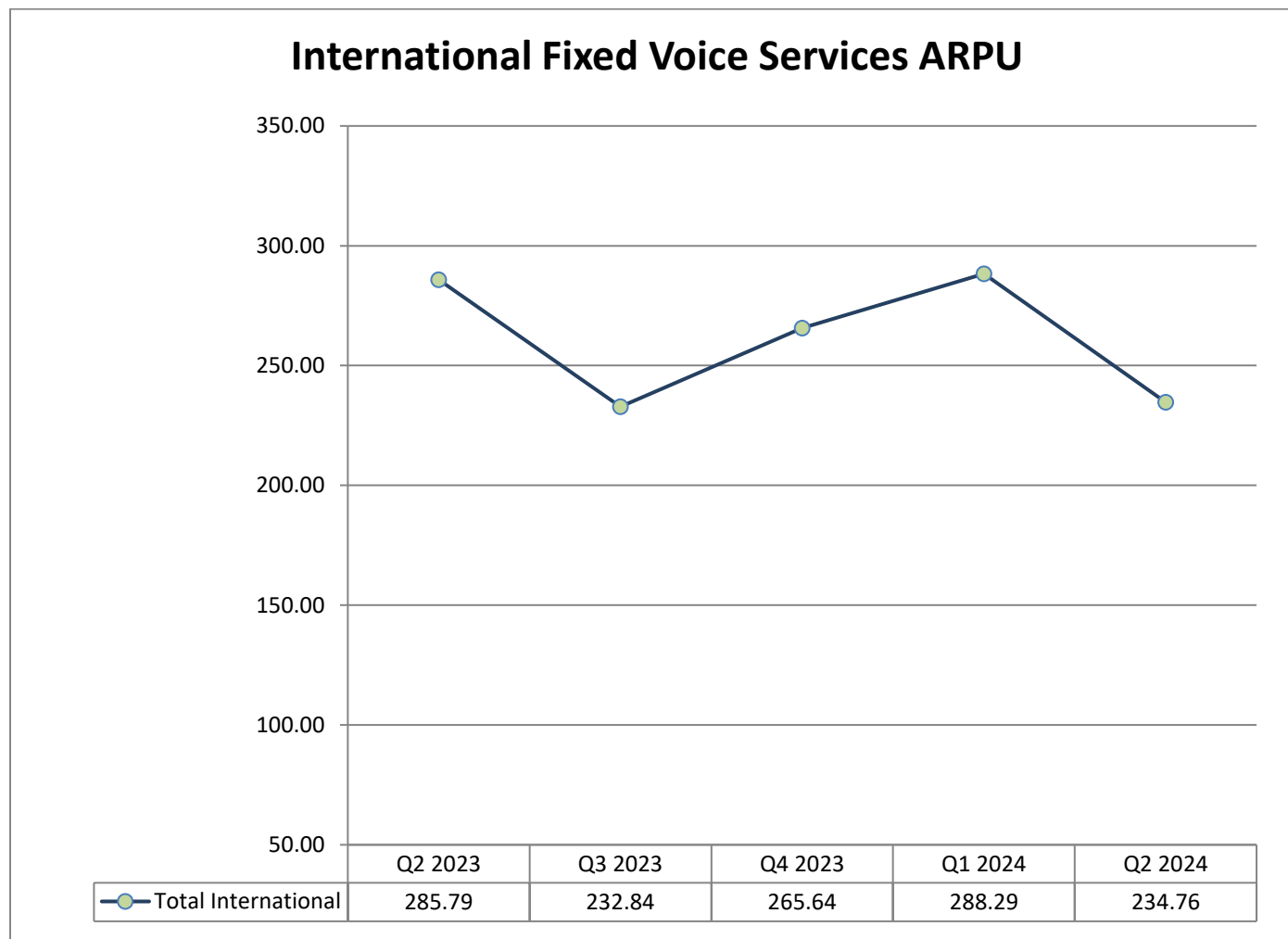

Figure 5: Gross Revenues from International Fixed Voice Services



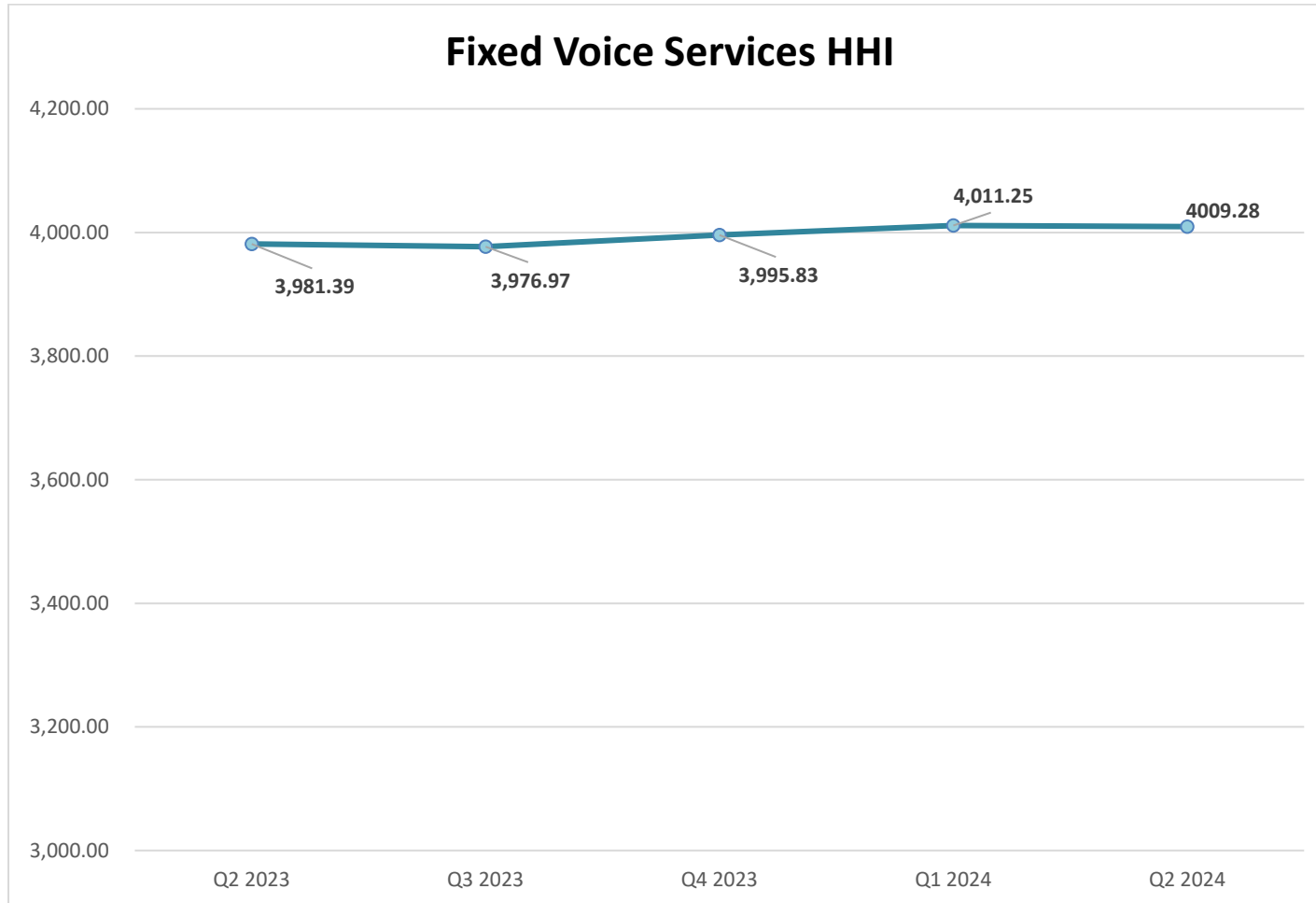

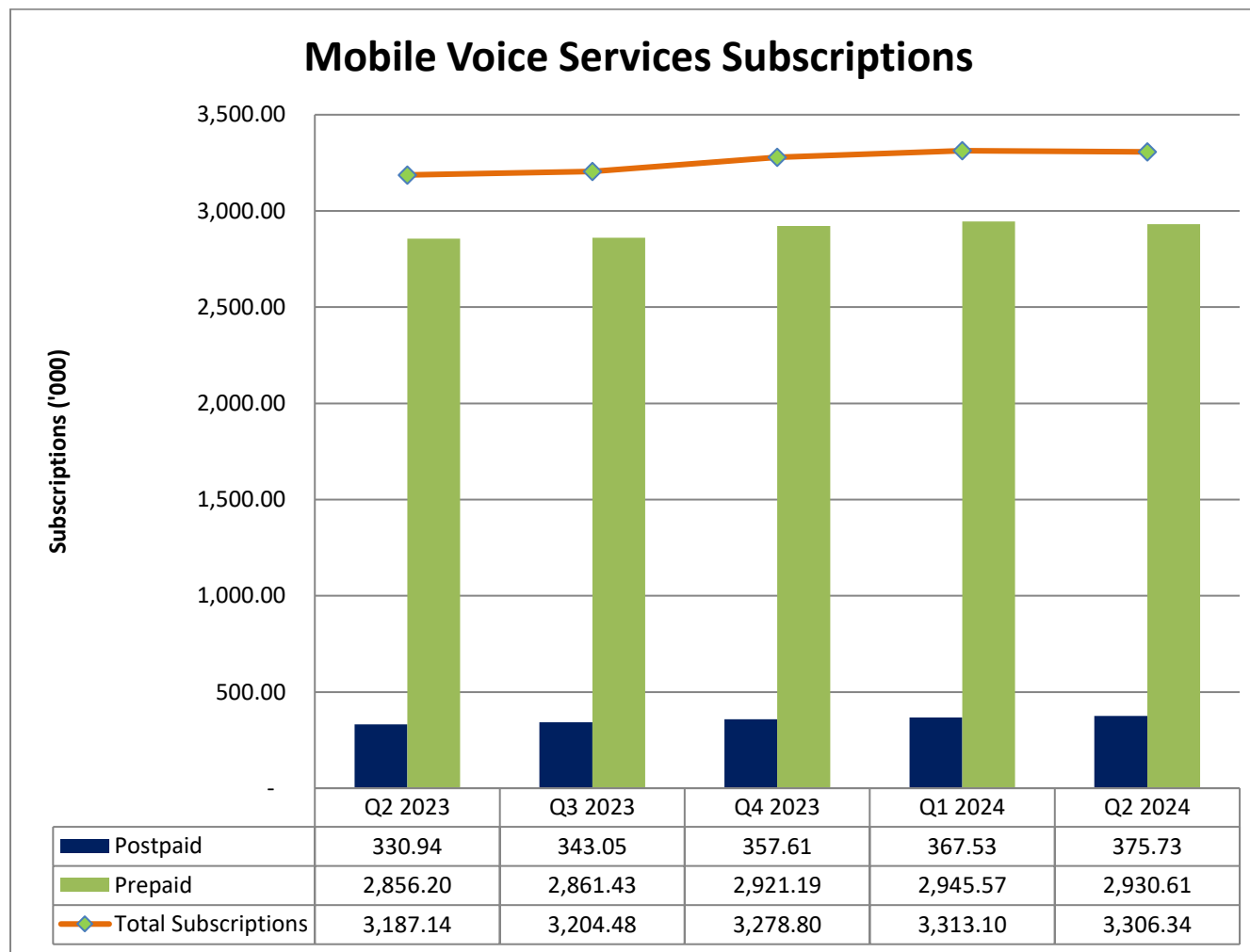
Figure 7: Fixed Voice Services Herfindahl-Hirschman Index (HHI)

Figure 8: Mobile Voice Services Subscriptions



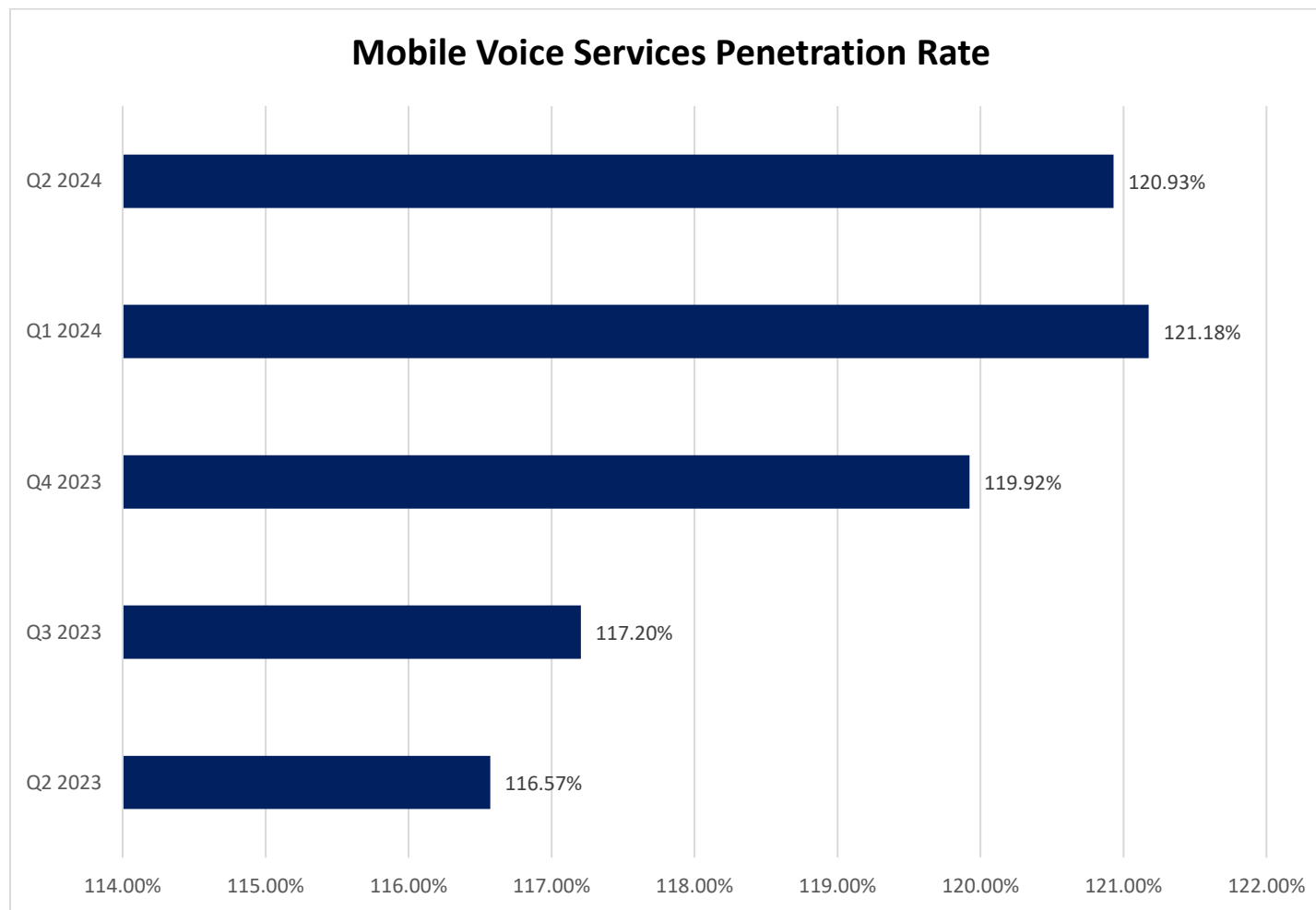

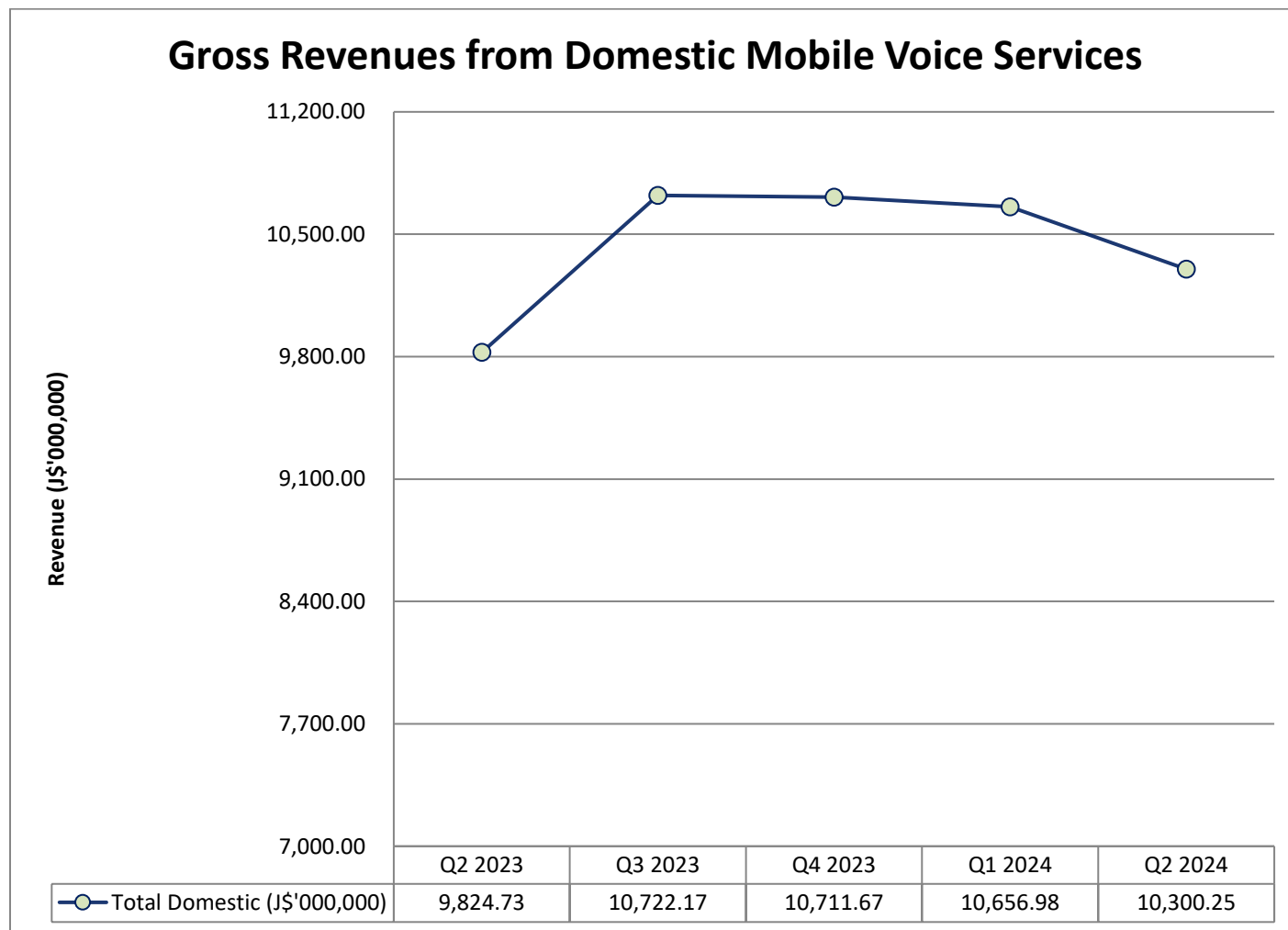

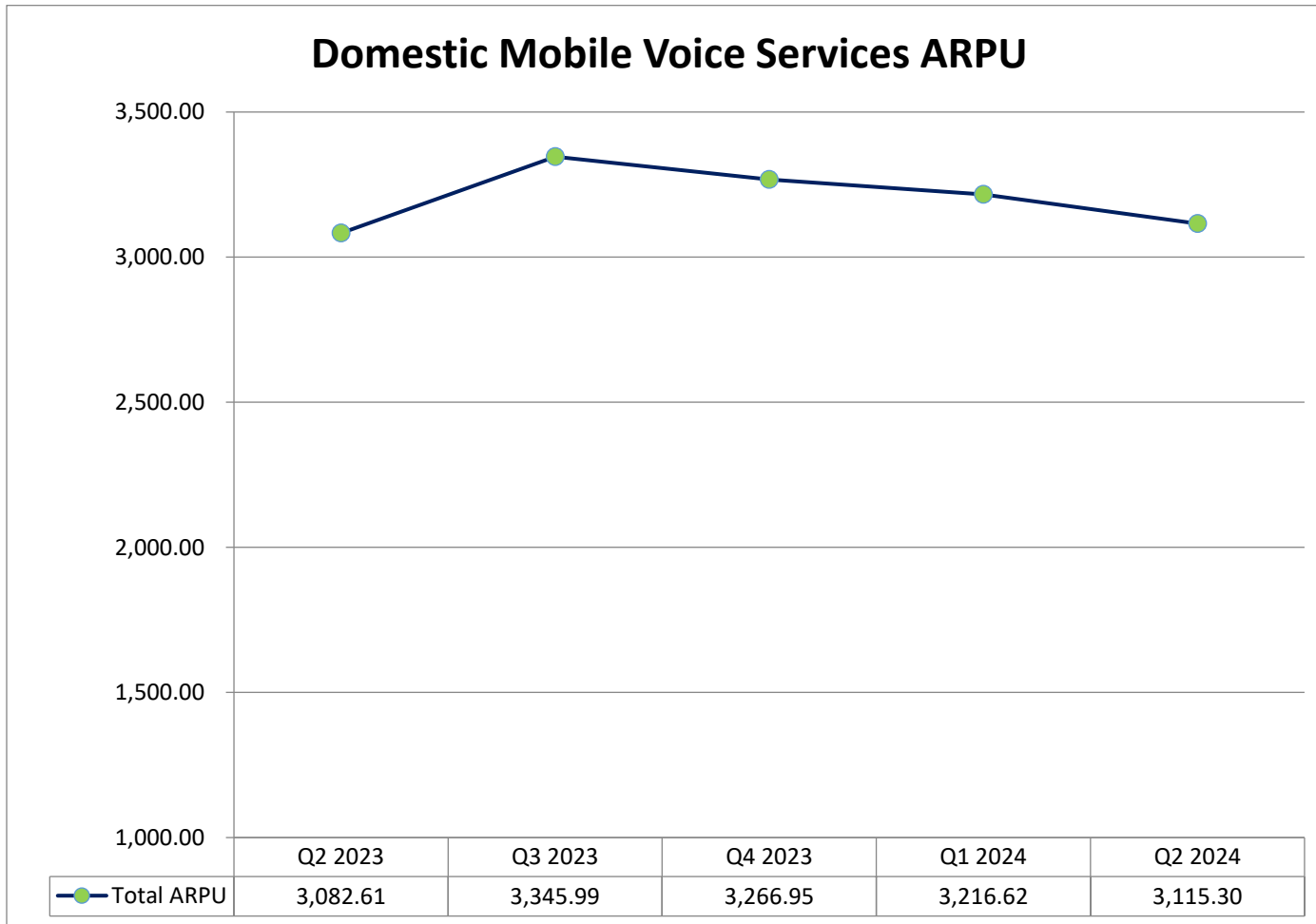
Figure 10: Gross Revenues from Domestic Mobile Voice Services

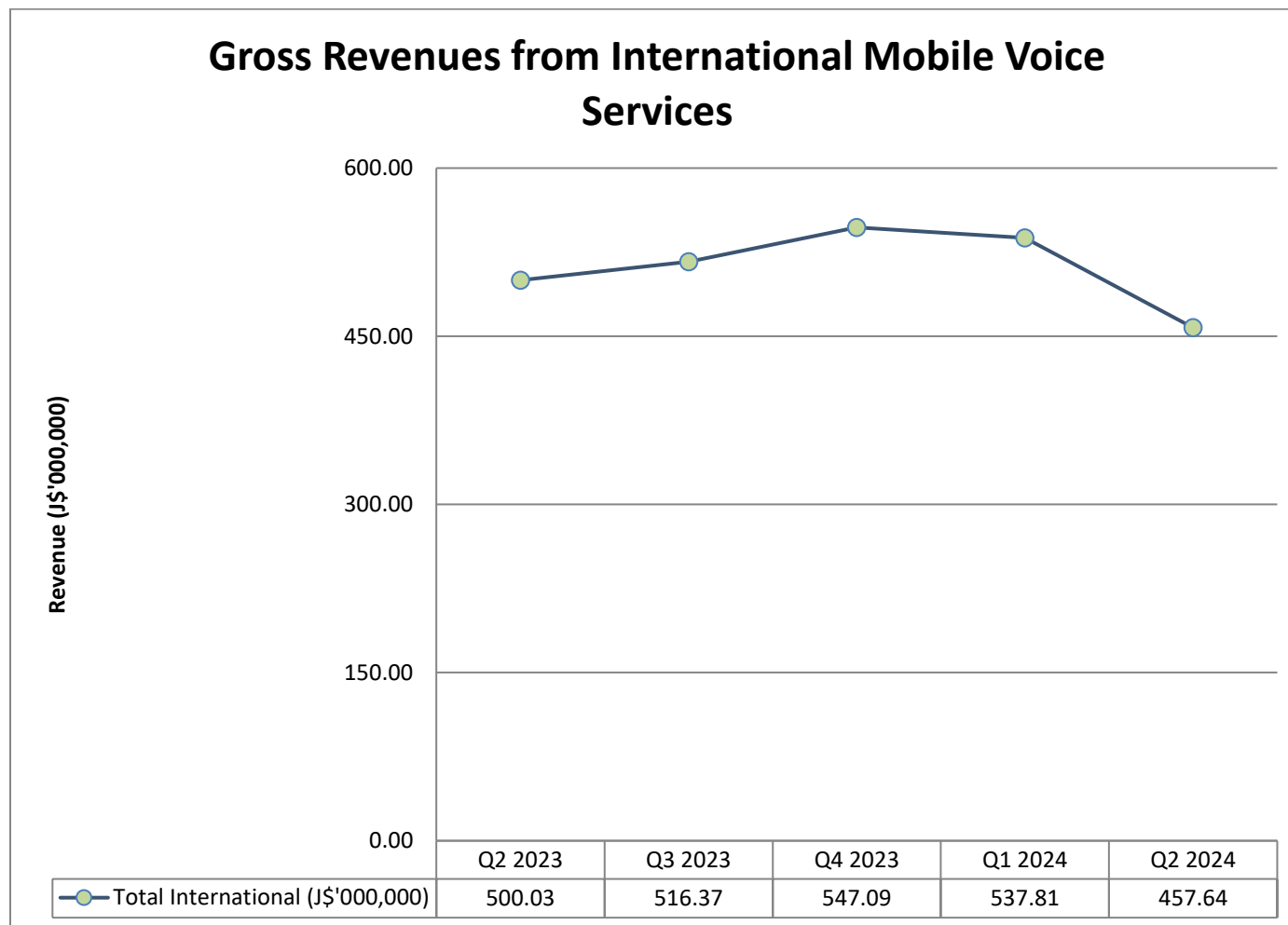

Figure 11: Domestic Mobile Voice Services Average Revenue per User (ARPU)



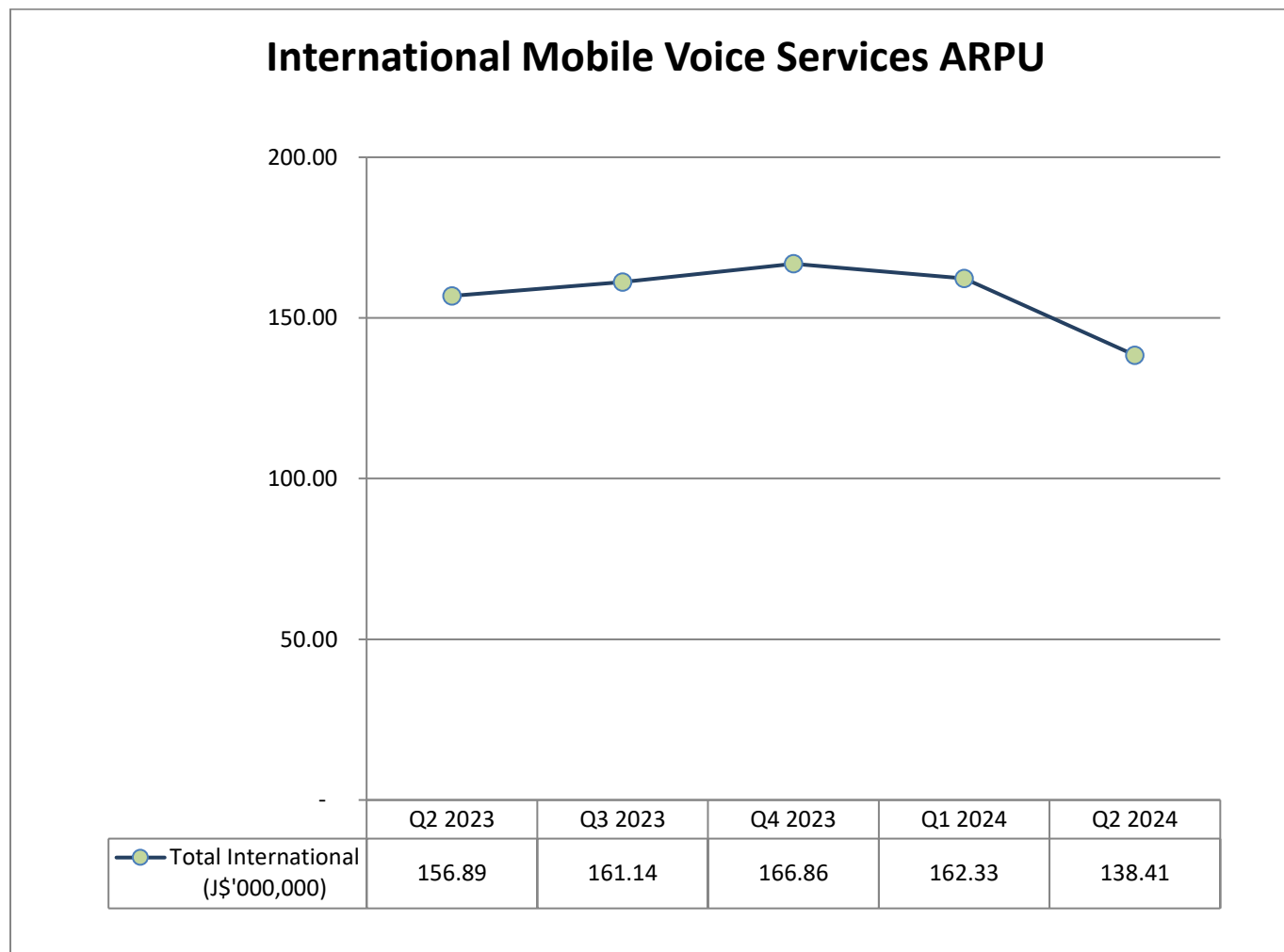

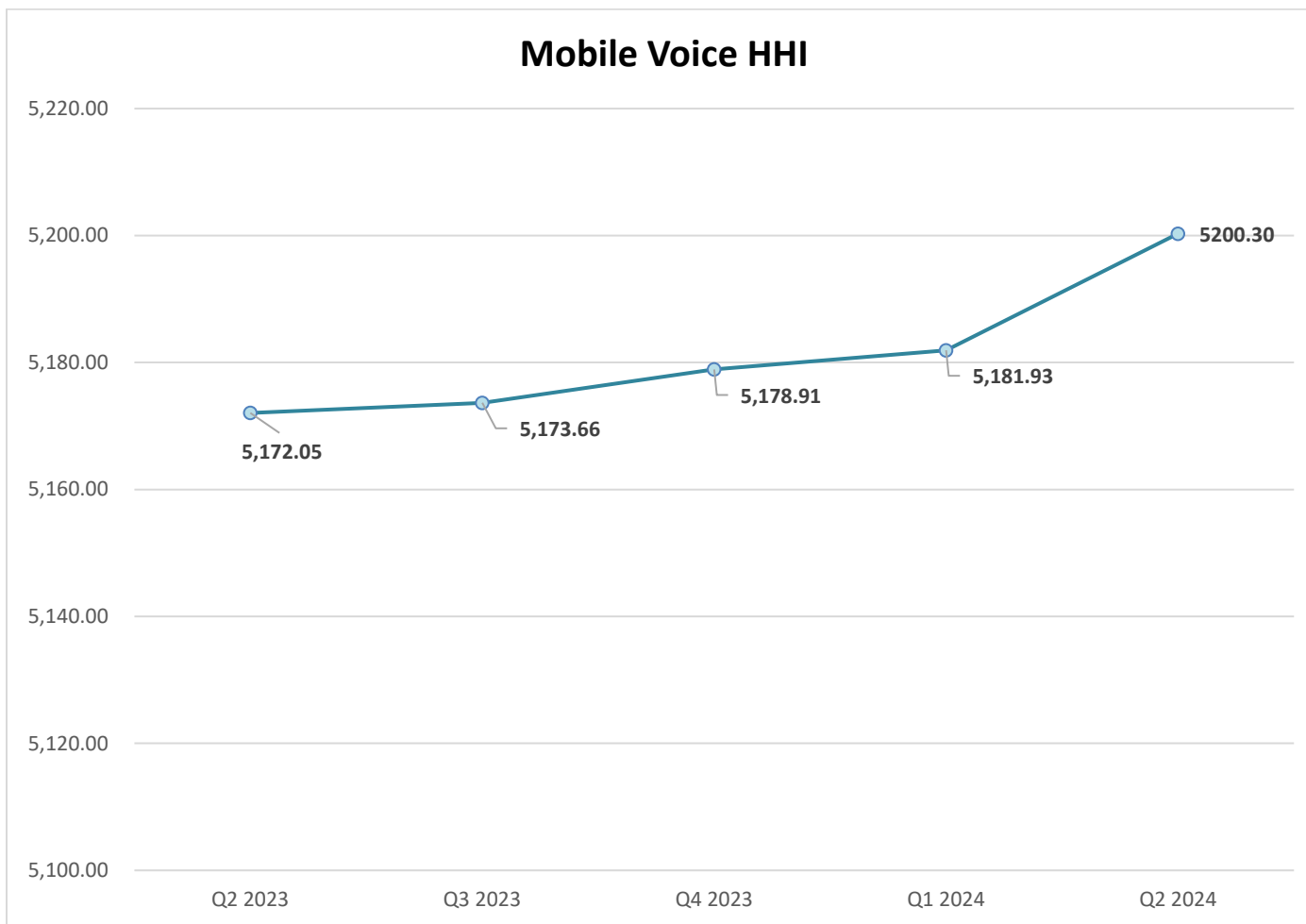
Figure 13: International Mobile Voice Services Average Revenue per User (ARPU)

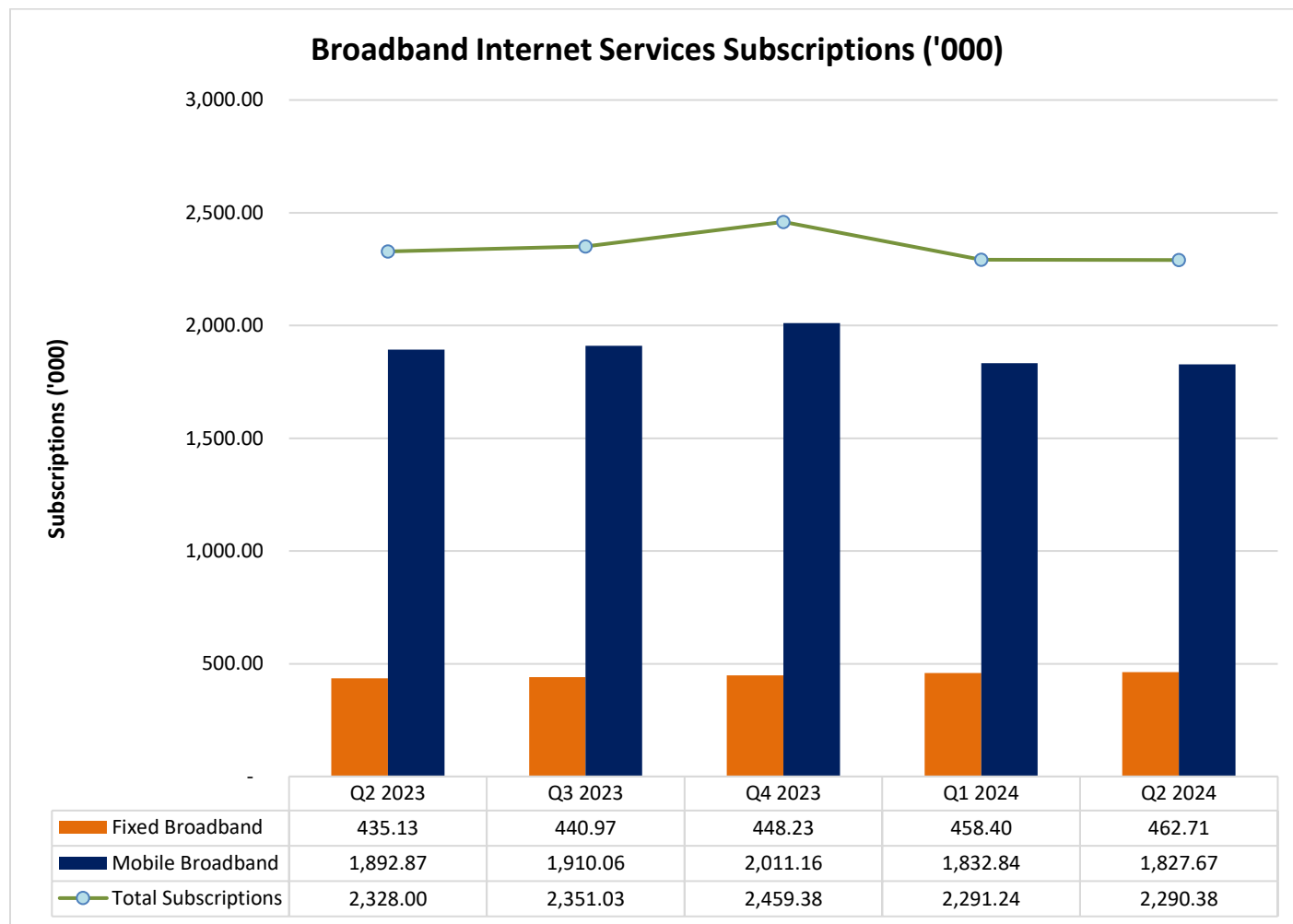
Figure 14: Mobile Voice Services Herfindahl-Hirschman Index (HHI)

Figure 15: Broadband Internet Services Subscriptions



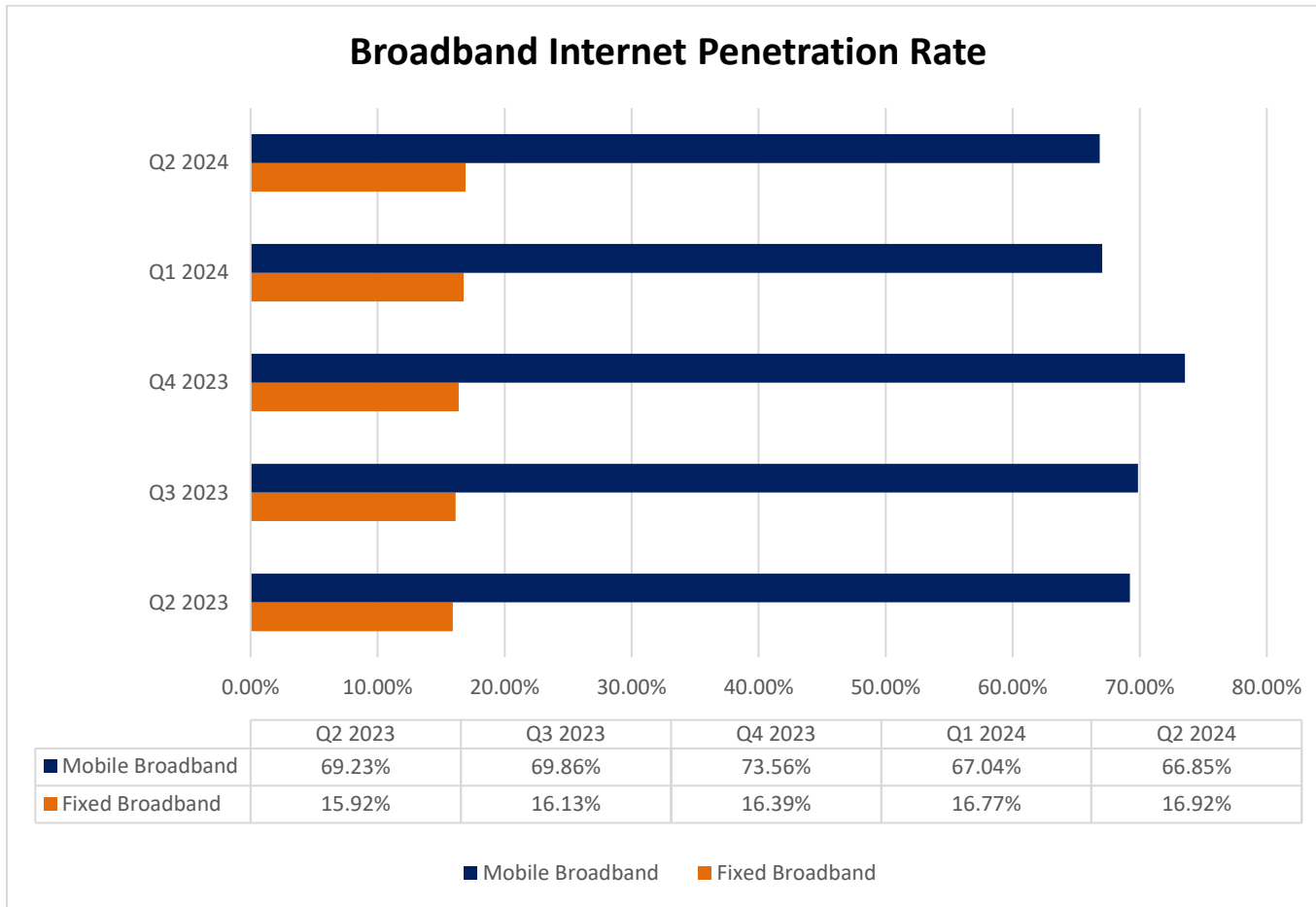

Figure 16: Broadband Internet Penetration Rate

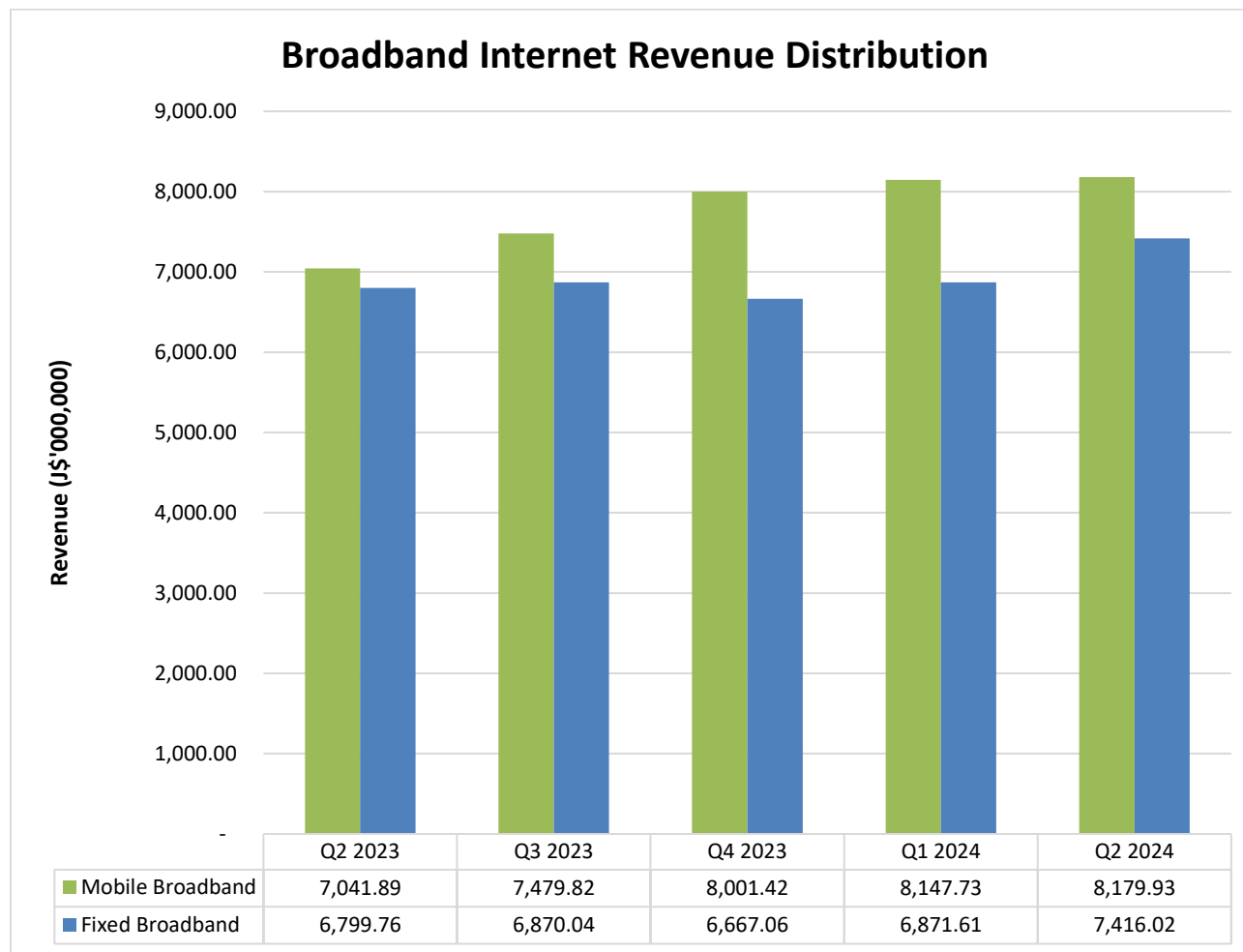

Figure 17: Broadband Internet Revenue Distribution

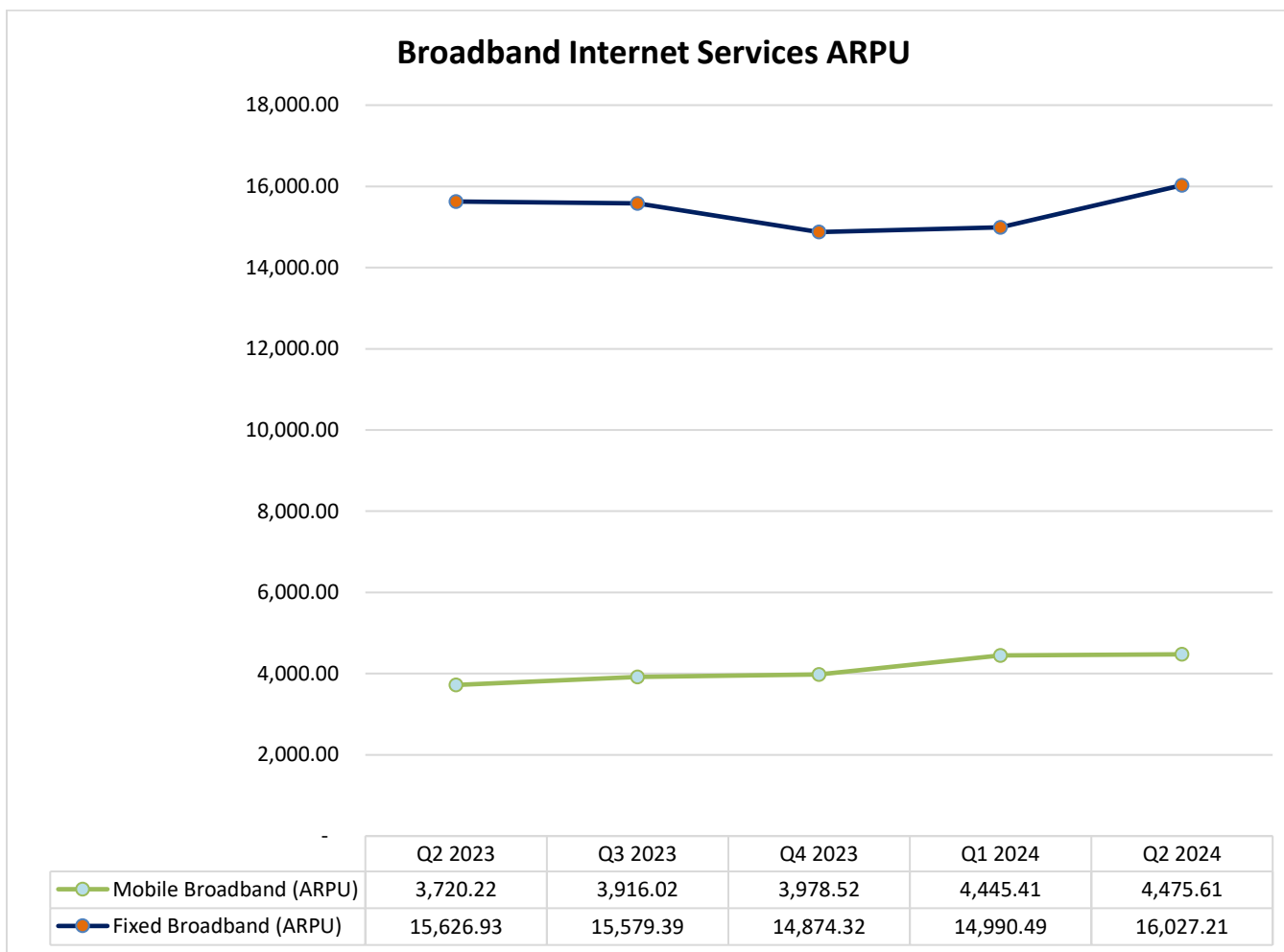

Figure 18: Broadband Internet Services Average Revenue per User (ARPU)

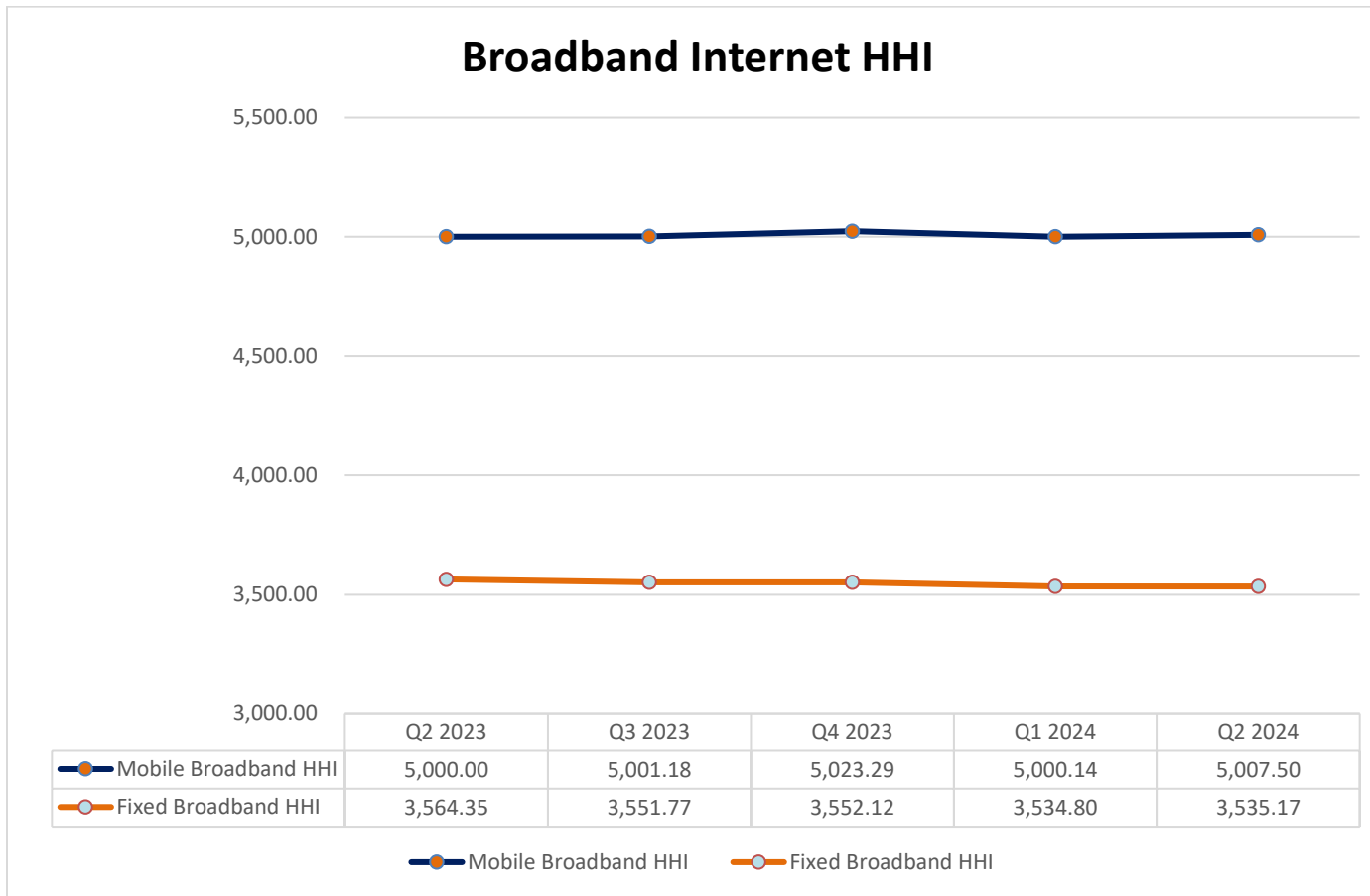
